Ref.: Tanker Pumper Bids for Replacement of Freeport Fire Rescue – Tank 2 and Engine 1

On August 11, 2021 at 1000 hrs., the bid opening for "Custom Tanker Pumper Apparatus" was conducted. Deputy Chief Eric Sylvain and Town Clerk Christine Wolfe were in attendance.

"Request for Bids" were sent to seven (7) vendors:

- 1. Allegiance Fire and Rescue Pierce
- 2. Greenwood Emergency Vehicles E-One
- 3. Dingee Machine Sutphen
- 4. Bulldog Fire Apparatus KME
- 5. Fleetmasters, Inc. Seagrave
- 6. Northeast Emergency Apparatus Ferrara
- 7. Lakes Region Fire Apparatus HME

The bids received were both from Allegiance Fire and Rescue (See Attached Sheet). The first bid assumed a contract would be signed by August 27, 2021, with Allegiance Fire Rescue having provided an extension for that price to September 8, 2021. The second bid assumes a contract signed after September 8, 2021. All bids assume membership in the Houston-Galveston Area Council (H-GAC) Cooperative Purchasing Program.

It is the recommendation of Deputy Chief Sylvain and I that the bid be awarded to Allegiance Fire and Rescue - Pierce, through the Houston-Galveston Area Council (H-GAC) Cooperative Purchasing Program.

It is our belief, after having examined the offerings of several fire apparatus manufacturers, that a custom Tanker Pumper from Pierce Manufacturing will provide the greatest level of quality, longevity of service, and most importantly, safety for our crews.

Chief Jordan, Deputy Sylvain,

As we discussed this morning at the bid opening, Pierce did have a price increase that was implemented on 8/1/21. We were able to get an extension on that increase until the end of business on 8/27/21. I explained to Pierce the schedule of council meetings for August and September and was able to get it extended until 9/8/21. To keep the price at \$656,401.00 before the prepay discount we must have a signed contract in hand by the end of business on 9/8/21. After 9/8/21 the price will increase to \$668,219.00. The prepay discount of \$19,724.00 remains for both price options.
