The 2023 Dog Warrant has been prepared and will be relinquished to the Animal Control Officer following the Council's endorsement. The Town Clerk's Office has taken many steps to accomplish ensuring that all Freeport dogs have been licensed for the year. We have sent email reminders in December and January, posted on the Town Website, FCTV3, Facebook and within Town owned properties. It was noticed in the Town Council announcements and in the Municipal Bulletin. The resulting list will now be turned over to ACO Brown for possible collection.

It is by this Order of the Council that we must follow this collection procedure:

Town Council Order #36-13, Municipal Warrant

Between February 1st and April 1st annually, the Municipal Officers of the Town of Freeport shall issue a warrant with the names and addresses of all owners of unlicensed dogs to one or more police officers or animal control officers, directing them to send a notice of violation to the last known address of the owners or call on the owners. The warrant must further direct that demand be made on the owners to obtain a license from the Municipal Clerk within seven (7) days from the date of demand and remit to the Clerk the license fees, plus a late fee of \$25.00 for each dog that is licensed. Finally, the warrant must direct the police officer or animal control officer to enter summons and complaint as soon as possible for all owners so notified who fail to comply with the order. Each police officer or animal control officer to whom the warrant is issued shall return the warrant to the Municipal Clerk on or before July 1st of each year.

You are also hereby directed to make a demand on the owner or keeper to obtain a license from the Municipal Clerk within seven (7) days from the date of the demand and to remit to the Clerk the license and recording fees, plus a late fee of \$25.00 per dog licensed.

Finally, you are hereby directed to enter summons and complaint as soon as possible for those owners/keepers who fail to comply with the order.

And you will make return of this warrant, with your doings thereon, to the Municipal Officers of said **MUNICIPALITY OF FREEPORT** by July 1^{st} of this year.
