An Act To Address Decibel Level Limits for Airboats

Sec. 1. 12 MRSA §13068-A, sub-§10, ¶A, as enacted by PL 2003, c. 655, Pt. B, 2 §380 and affected by §422, is amended to read: 3 A. A person may not operate a motorboat in such a manner as to exceed: 4 (1) A noise level of 90 decibels when subjected to a stationary sound level test 5 with and without cutouts engaged and as prescribed by the commissioner; or 6 (2) A noise level of 75 decibels when subjected to an operational test measured 7 with and without cutouts engaged and as prescribed by the commissioner. 8 As used in this paragraph, "motorboat" does not include an "airboat," which has the 9 same meaning as in paragraph A-1. 10 Sec. 2. 12 MRSA §13068-A, sub-§10, ¶A-1 is enacted to read: 11 A-1. A person may not operate an airboat in such a manner as to exceed noise level 12 limits established by the commissioner by routine technical rules as described in Title 13 5, chapter 375, subchapter 2-A. For purposes of this paragraph, "airboat" means a 14 flat-bottomed watercraft propelled by an aircraft-type propeller and powered by 15 either an aircraft engine or an automotive engine. 16 Sec. 3. Collection of information. The Department of Inland Fisheries and 17 Wildlife and the Department of Marine Resources jointly shall solicit and collect 18 information regarding airboats, including, but not limited to, information regarding uses 19 of airboats, noise levels and complaints and suggestions for reducing complaints 20 regarding the use of airboats, from interested parties, including, but not limited to, harbor 21 masters, town clerks and residents of coastal towns and airboat users and sellers. Based 22 on the suggestions, the Commissioner of Inland Fisheries and Wildlife and the 23 Commissioner of Marine Resources may submit legislation to the First Regular Session 24 of the 130th Legislature to implement whatever suggestions the commissioners determine 25 are necessary. As used in this section, "airboat" means a flat-bottomed watercraft 26 propelled by an aircraft-type propeller and powered by either an aircraft engine or an 27 automotive engine. 28 **SUMMARY** 29 This bill exempts airboats, which are defined as flat-bottomed watercraft propelled by 30 an aircraft-type propeller and powered by either an aircraft engine or an automotive 31 engine, from the noise level limits imposed on other watercraft. Instead, this bill allows 32 the Commissioner of Inland Fisheries and Wildlife to establish noise level limits for 33 airboats by routine technical rules. 34 This bill also requires the Department of Inland Fisheries and Wildlife and the 35 Department of Marine Resources to jointly solicit and collect information regarding 36 airboats, including uses of airboats, noise levels and complaints and suggestions for 37 reducing complaints regarding the use of airboats, from interested parties, such as harbor 38
