Comprehensive Planning in Maine


- Growth Management Law enacted in 1989; various updates since, including being repealed and reinstated in 1991
- Codified at M.R.S.A. Title 30-A Chapter 187, Planning and Land Use Regulation, §4301-4349-A
- Potential modifications to Growth Management Law related to Comprehensive Planning is in committee.

- Three main elements:
 - Inventory & analysis of existing conditions
 - Develop policies & strategies to respond to topics raised in inventory analysis
 - Vision Statement and Future Land Use Map & Plan
- Although not a part of State statute, you can't forget about public engagement throughout the process!

Role of the Comprehensive Plan

What it does

- Broad, high level vision & guidance
- Identifies priorities, presents options
- Continuity, common framework

What it doesn't do

- Not the Plan to end all Plans
- Doesn't presume new opportunities or challenges won't arise
- Not a club to wield, but a touchstone to get guidance from





Planning Board Role & Responsibility

- 1. Provide direction to the Planning Department and the selected consultant in preparation for the Comprehensive Plan update;
- 2. Participate in the development and review of the inventory and analysis of existing conditions in various topic areas;
- 3. Participate in the public engagement program;
- 4. Along with the general public, refine the vision statement;
- 5. Participate in the development of policies, goals and strategies, and the future land use plan;
- 6. Participate in the development of the implementation program; and
- 7. Participate in the public presentation of the final draft comprehensive plan.
