Councilor Mann voiced his concerns with the Town Charter requirements regarding adequate public notice and publication. He noted that the Council is repealing Chapter 25 of the Ordinance and proposing a whole new Ordinance. He mentioned that he discovered that the Library does not have the old Ordinance containing the strike-out type highlighting the changes which would make it easy for residents to see what is being changed. This is a requirement of the Charter and needs to be provided. The Charter also requires that the complete text or a summary Of the text be made available. The newspaper publications need to advertise where the copies Will be located and the times and dates of the public hearings. He wants to be sure that all these things are done, particularly since the public hearings are being rescheduled. Discussion followed.
