Town Manager Olmstead reported on the "tax acquired property"; we have a number of properties that have been on the tax rolls and would go back some 15 years; I found no procedure for disposing of these properties; we would contact the abutters and offer them first refusal; the Assessor and I would set a fair price for the property; if the abutter chose not to buy the property, then it would go out to bid again; the Town would accept only a "minimum bid" for the property; I would recommend that the Council develop a policy for disposition of tax acquired property. Acting Chairman Palmer stated that Council would discuss this matter at the next Council workshop.

David Thompson, Planning Board, stated there is an order that reads: "before any property is sold or put up for bid, it should be looked at by the Recreation Committee to see if they can use the property". Council agreed this was a good policy to follow.
