

Be It Ordered - That the Town Council of the Town of Freeport, Maine, hereby authorize the Town Manager to execute and deliver, on behalf of the Town, an Inducement Agreement (substantially in the form attached hereto and incorporated herein by reference) between the Town and the Dingley Press (and/or the principals thereof) which Agreement provides for the issuance by the Town of up to One-Million Seven-Hundred Thousand Dollars (\$1,700,000.00) of Revenue Obligation Securities for the construction of an addition to its printing plant in Freeport and the acquisition of equipment for use in such plant.

Be It Further Ordered - That the Town Council of the Town of Freeport, Maine, hereby evidences its present intent to issue the Town's Revenue Obligation Securities in an amount not to exceed \$1,700,000.00, upon the conditions set forth in the Inducement Agreement and subject to the approval of the Finance Authority of Maine, and further authorizes the Town Manager to prepare and submit to the Finance Authority of Maine on behalf of the Town, a municipal application seeking approval of the issuance of such Revenue Obligation Securities, and to take such other steps as he may deem necessary or appropriate in order to obtain a certificate of approval from the Finance Authority of Maine pursuant to Section 1063 of Title 10 of the Maine Revised Statutes. (Councilors Nelson & Lunt)

(6 Ayes) (1 Abstain, Councilor Curtis)

There was a brief discussion held with Bustins Island representatives, Mr. David Pease and Mr. Leonard Larrabee. issues covered and resolved were: (1) Councilor Lunt wanted to have specifications drawn up pertaining to future bonding; the rate of interest would be at the same interest that the Town would be paying. (2) Council wanted to determine legal costs of developing some documents; Bustins did not foresee any fees except to the Town Attorney; on a vote taken by the Council - 4 indicated that the Town should pay the Town Attorney's legal fees in full - 3 indicated they wanted the Town to pay one-half and Bustins the other half. (3) Who should pay for the fire truck - on a vote by the Council - 5 stated the Town should pay debt service on the fire truck -2 stated Bustins should. Bustins will be forthcoming with new language for the Agreement covering the above stated issues.
