<u>WHEREAS</u>, The presence of nuclear weapons in the world and the possibility of their use makes the preservation of peace the primary issue of our time, and

<u>WHEREAS</u>, The United States and the Soviet Union, as the leading military powers in the world, bear a special responsibility for the preservation of peace, and

WHEREAS, The causes of peace and understanding may be advanced through a relationship between the people of a city in the Soviet Union and the people of Greater Portland involving exchanges of visits, letters, arts, sports, business, culture, education and other aspects of life in our respective cities, and

WHEREAS, Other cities throughout the United States have already established relationships with Soviet cities, and have found these relationships helpful in promoting mutual understanding, and

WHEREAS, The Archangel Committee has been formed to encourage the development of a relationship between Greater Portland and the City of Archangel in the Soviet Union, and

WHEREAS, This Resolution documents the Town of Freeport's support for the immediate preservation of the public peace, health, safety and welfare,

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF FREEPORT, That the Town of Freeport declares its desire that a relationship be formed between the Peoples of Greater Portland and the City of Archangel for the purpose of promoting peace, understanding and exchanges of culture and talent between our two peoples.

Town Manager Olmstead explained that the Regional Waste Systems is scheduled to begin accepting the Town's waste on June 1, 1988; as of June 1, residents will not be able to take their trash to the landfill; they must contract with a commercial hauler to transport their waste to the landfill; people are encouraged to still recycle.

Other Business:

1. Discussion on political announcements/advertisements on Cable TV Channel 6; Chairperson Bonney explained that the School Committee has requested the use of the cable tv channel as a means of advertising the school referendum questions; Town Manager Olmstead stated that the prior Chairman of the Cable TV Committee stated that no political advertising is allowed on the station; the present Cable TV Committee will research this ruling as they were not aware of a specific rule not allowing political discussion on the tv channel; after much discussion three councilors felt that anyone should be able to access the cable tv station for any type of information; two councilors were against using the cable tv for any type of political forum; the Cable TV Committee will form a policy regarding this issue.

- 2. Report from the Ordinance Committee: Chairman Hartnett briefly discussed some of the issues taken by the Committee, i.e. a Loitering Ordinance; issues pertaining to bed and breakfast guests relating to downtown merchants; there was much talk about "rowdy groups" hanging around the downtown area; the proposed amendments will be presented at a public hearing in November.
- 3. Council has received a request for a memorial to be placed at Winslow Park; Council wishes the Winslow Park Commission to make recommendations; John Nelson mentioned some suggestions that have been made.
- 4. Repairs to the B.H. Bartol Library: Town Manager Olmstead suggested waiting until the bids are in on the repair work; the Capital Budget might be able to take care of it.
- 5. Town Manager Olmstead reminded the Council that Maine Municipal Association is having their convention on October 14 through 16; if anyone is interested in going, let him know.
- 6. Mr. Olmstead reminded councilors that on October 20 they should plan on having pictures taken for the Annual Report.
- 7. A meeting is scheduled with the Chief of Police for Saturday morning with some councilors and the Town Manager.
- 8. Edward Bonney & William Grady attended the Ethics Meeting held in Yarmouth and both found it to be very informative.
