#### Other Business:

1. Vice-Chairperson Nelson mentioned a resolution that was passed by the House of Representative and the Senate regarding missing Vietnam vets and prisoners of war; of 2500 men missing - 1800 have been declared as killed in action by the Pentagon - their bodies were never recovered; over 400 were Navy flyers that went down in the water; Mr. Nelson stated there is no documentation that there are MIAs or POWs - most of the families are 100% certain the men have been killed in action and wish to put this issue at rest.

The Resolution was encouraging municipalities to fly "prisoner-of-war" and "missing-in-action" Flags and had been endorsed by the Members of the 113th Legislature.

2. Opdate on Library Renovation Project:

Bids were received last week from the following six companies:

Guerette Construction for \$125,000
Pelletier & Flanagan for \$121,800
C.P.M. Constructors for \$128,966
Woodward Thomsen for \$142,000
C.M. Cimino for \$154,000
J.A. Languet Construction for \$164,000

Because the first 3 bids were so close, it was decided to choose the one that came out best on a reference check - Pelletier & Flanagan came out with the best reference checks; The Town has \$95,670 in the Library Account; the architect is charging \$3,000 to oversee the project; the base bid without the alternatives is \$134,000 - we can eliminate roughly \$14,000 by cutting out less expensive lighting, carpeting, etc. At this point, the project is short \$25,000 plus \$10,000 for the alternatives. Town Manager Olmstead suggests that the bid be awarded to Pelletier & Flanagan at the price of \$136,290 and plan to negotiate with them to get the figure down as low as possible; the Library Project would result in a Childrens' Room, a Periodical Room and a Small Meeting Room.

- 3. Rich Golden, Chairman of the Planning Board, and Dave Thompson, Bridget Healy, and Jacki Cohen, Town Planner, discussed with the Council the many planning concerns and projects that are coming before them. The major issues discussed were:

  - 2) Revisions to Sub-Division Ordinance
  - 3) Residential Acreage
  - 4) Growth in Town/Residential Sub-Divisions
  - 5) Plumbing Code
  - 6) Low Income Housing
  - 7) Surface Water Run-Off
  - 8) Growth in the Schools
  - 9) Sewer District Utilization
  - 10) Clustering
  - 11) Bonus Incentive to Contractors for Affordable Housing
  - 12) Capping Building Permits
  - 13) Industrial Base

Planning Board has scheduled a workshop next week.

4. Chairperson Hartnett inquired about "stop signs"; Town Manager reported signs have been set on Middle and Harraseeket; Council agrees to put the signs up contingent on a "trial basis".

5. Chairperson Hartnett mentioned the fact that the Town needs at stiffer "Conflict of Interest" Ordinance. Councilors would like to have some policies developed by the Town Attorney.
