ORDINANCE AUTHORIZING ISSUANCE OF BONDS FOR A 1982 GRUMAN AERIAL LADDER FIRE ENGINE.

The Town of Freeport Hereby Ordains the following: That, under and pursuant to the provisions of the Charter of the Town of Freeport, a sum not to exceed \$130,000.00 is hereby appropriated to meet the estimated cost of a 1982 Gruman Aerial Ladder Fire Engine, and to meet said appropriation, the Treasurer and Chairman of the Town Council are authorized to issue general obligation securities of the Town of Freeport in an aggregate principal amount not to exceed \$130,000.00, and the discretion to fix the date(s), interest rate(s), maturity(ies), denomination(s), place(s) of payment, form(s) and other details of said securities and to provide for the sale thereof, including execution and delivery thereof against payment therefore, is hereby delegated to the Treasurer and Chairman of the Town Council.

Be It Further Ordered - That a Public Hearing be held on the subject of this referendum question on April 19, 1988 at 7:30 P.M. at the High School Media Center, notice of which shall be posted in the same manner required for posting of an Election Warrant at least seven days prior to the date of the Public Hearing.

RECOMMENDATION AND EXPLANATION: This proposed purchase of a 1982 Aerial Ladder Fire Engine is to replace an existing 1948 Aerial Ladder Fire Truck. The Freeport Town Council recommends the adoption of this Ordinance.

The Town of Freeport Hereby Ordains the following: That, under and pursuant to the provisions of the Charter of the Town of Freeport, a sum not to exceed \$400,000.00 is hereby appropriated to meet the estimated cost of a Landfill Closure Project, and to meet said appropriation, the Treasurer and Chairman of the Town Council are authorized to issue general obligation securities of the Town of Freeport in an aggregate principal amount not to exceed \$400,000.00, and the discretion to fix the date(s), interest rate(s), maturity(ies), denomination(s), place(s) of payment, form(s) and other details of said securities, and to provide for the sale thereof, including execution and delivery thereof against payment therefore, is hereby delegated to the the Treasurer and Chairman of the Town Council.

Be It Further Ordered - That a Public Hearing be held on the subject of this referendum question on April 19, 1988 at 7:30 P.M. at the High School Media Center, notice of which shall be posted in the same manner required for posting of an Election Warrant at least seven days prior to the date of the Public Hearing.

RECOMMENDATION AND EXPLANATION: This proposed Landfill Closure Project is a requirement imposed on the Town of Freeport by the Maine Department of Environmental Protection. The closure of the Landfill must commence no later than August 1, 1988. If this bond issue is not approved by the Voters of the Town of Freeport, the project will have to be funded through the Town's Operating Budget. The Freeport Town Council recommends adoption of this Ordinance.
