Motion to Amend Item #49-88 as follows:

Article III - Parking Provisions.

Section 48-302 No Parking Zones

Amend to read as follows:

- 57. On the east side of Main Street from West Street to Chapel Street, except where permitted by other sections of this ordinance. Illegally parked vehicles will be towed.
- 58. On the west side of Main Street from West Street to Mallet Drive, except where permitted by other sections of this ordinance. Illegally parked vehicles will be towed.

Section 48-306 Thirty Minute Parking Zones.

- 4. On the east side of Main Street from the southern corner of Main Street and Mill Street extending in a southerly direction 185 feet.
- 5. On the east side of Main Street from the northern corner of Main and Mill Streets extending in a northerly direction 175 feet.
- 6. On the east side of Main Street beginning 140 feet northerly of the School and Main Street intersection extending 280 feet in a northerly direction.
- 7. On the west side of Main Street from the northerly corner of West and Main Streets extending in a northerly direction 220 feet.
- 8. On the west side of Main Street beginning 70 feet from the southerly corner of the Nathan Nye Main Street intersection extending in a southerly direction 155 feet.

Section 48-307 Taxi Stand Parking Zone.

Leave language in the ordinance as currently written.

Section 48-308 Fifteen Minute Parking Zones.

- 1. On the east side of Main Street from the northerly corner of Mechanic and Main Streets extending northerly 115 feet.
- 2. On the west side of Main Street from the northerly corner of Main and Elm Streets extending in a northerly direction 170 feet.
- 3. On the west side of Main Street from the Post Office driveway (Map 12, Lot 26) extending in a northerly direction 320 feet.

# Section 48-312 Handicapped Parking

- 1. On the east side of Main Street in front of Derosier's Market (Map 11, Lot 93) that area which is closest to the designated loading zone. (One space)
- 2. On the east side of Main Street in front of Praxis (Map 13, Lot 20) the most southerly parking space. (One space)
- 3. On the east side of Main Street in front on the Timberland Building (Map 11, Lot 121) the most southerly parking space.

  (One space)
- 4. For regular church services, handicapped parking will be allowed in front of church buildings. Hours will include from 5:00 p.m. to midnight on Saturdays and 8:30 a.m. to 1:00 p.m. on Sundays.

Section 48-314 Parking for Church Activities

As long as churches remain located on Main Street, parking immediately in front of church buildings will be allowed for weddings, funerals and other special events. Church leaders will notify the police department at least twelve hours prior to the scheduled activity and will be allowed to use portable municipal signs to mark parking areas.
