ARTICLE VI, SECTION 8 - TOWN HOIST

- A. Boats shall be launched* from the Hoist on the Town Wharf only by appointment with the Harbormaster. In the event of a scheduling conflict, fishing vessels and island vessels shall always have priority. No boats shall be launched* during weekends* during the period 15 May 15 September.
- B. No commercial launching* of boats from the Hoist shall be allowed.
- C. No load in excess of 4,000 pounds shall be placed upon the Hoist.
- D. The Harbormaster may terminate any use that he deems in his sole discretion to be unsafe.
