to fix the date, place of payment, forms, and other details of the
securities, and providing the sale thereof delegated to the Chairman
of the Town Council and the Town Treasurer."

Town Manager Olmstead explained that \$12,500.00 is left over from the Fiscal Year 1988 Operating Budget and will go into Surplus. Also, there is a balance left of \$11,971.17 in the Miscellaneous and Contingency Account.

Other Business:

1. Town Manager Olmstead attended a recent Manager's Meeting where there was some concern among three towns that the correct population figures were not being used, thus depriving the towns of more revenues for roads and state revenue sharing; the three towns are Scarborough, Falmouth and Freeport; it will cost approximately each town \$1,700 to take this case to the State. Councilors agreed the money and gamble was worth it.

Be It Ordered - That an amount not to exceed \$1,700.00 be transferred from the Fiscal Year 1988 Operating Budget's Miscellaneous and Contingency Account to fund a Study of the Current Population Figures for the Town of Freeport.

- 2. Town Manager Olmstead needed direction from the Council regarding the Sewer District; they are only able to accept 3,000 gallon tanks, but, there are three companies in town that have 5,000 gal. tanks and the Town will have to find an alternate dumping place for these businesses, who are, Winslow Park, Freeport Nursing Home and Freeport Inn; Portland Sewer District will accept the dumping, however, they are requesting that an agreement be signed an agreement should be signed and a user fee be pro-rated among the three establishments.
- 3. Councilor Stevens brought up what he thought was a "conflict of interest" problem regarding himself, however, Council saw no problem.
- 4. Councilor Goddard engaged the Council in talking about who's responsibility is it for a business dumping into the sewer system, who should pay user or dumping fees; most councilors felt a more detailed description should be made.
- 5. Chairman Hartnett brought up directional signs on U.S. Route 1; there was mention at one time of a "welcome sign" just over the bridge and many businesses were again inquiring if they could be put on a directional sign in the Village area; two major concerns were expressed: 1) consolidating many little signs into one sign, and 2) perhaps a "Welcome to Freeport" sign; the Ordinance Committee will look into these issues.
