She did not have any magic ball projections but said for planning purposes, on the municipal side of the budget, Freeport should optimistically anticipate level funding and the same on the school side of the budget but she didn't know what the exact figures will be. Mr. Lyman also shared his concerns about potential financial problems.
- Mr. Olmstead mentioned that the Council needs to schedule an Appointments Committee meeting for the 22nd of September.



AMENDMENT TO THE TRAFFIC & PARKING ORDINANCE (CHAPTER 48)

Section 48-301 No Parking Zones

No vehicle shall stand, stop, or park at any time in any of the following specified locations

65. On the easterly side of Depot Street from Bow Street extending southerly 135 feet.

Note: This amendment will allow for the creation of left and right turn lanes at the Depot Street/Bow Street intersection. Three parking spaces will be lost.



## CHAPTER 32 SHELLFISH CONSERVATION ORDINANCE

### TOWN OF FREEPORT

- 1. AUTHORITY: This Ordinance is enacted in accordance with 12 M.R.S.A., Section 6671.
- 2. **PURPOSE:** To establish a Shellfish Conservation Program for the Town of Freeport which will insure the protection and optimum utilization of shellfish resources within its limits. These goals will be achieved by means which may include:
  - A. Licensing;

- B. Limiting the number of shellfish harvesters;
- C. Restricting the time and area where digging is permitted;
- D. Limiting the minimum size of clams taken;
- E. Limiting the amount of clams taken daily by a harvester.
- 3. EFFECTIVE DATE, DURATION, AND AMENDMENT;
  - A. <u>Effective Date</u>: This Ordinance which has been approved by the Commissioner of Marine Resources shall become effective after its adoption by the Municipality. A certified copy of the Ordinance is filed with the Commissioner within twenty (20) days of its adoption.
  - B. <u>Duration</u>: This Ordinance shall remain in effect for three (3) years from its adoption. It shall be repealed by operation of law at that time. Should the Town desire to continue with a Municipal Conservation Program, the Ordinance must be replaced on or before the time of repeal by this or a similar Ordinance.
  - C. <u>Amendment</u>: This Ordinance may be amended from time to time by the Town Council. Prior to adopting an amendment, the written approval of the amendment by the Commissioner of Marine Resources shall be filed with the Town Clerk. A certified copy of any amendment adopted by the Town Council shall be filed with the Commissioner of Marine Resources within 20 days of its adoption.
- 4. SHELLFISH CONSERVATION COMMISSION: The Shellfish Conservation Program for the Town of Freeport will be administered by the Shellfish Conservation Commission consisting of five (5) members to be appointed by the Freeport Town Council for terms of three (3) years. The Commission's responsibilities include:

- B. <u>Nonresident</u>: The word "Nonresident" means anyone not qualified as a resident under this Ordinance.
- C. <u>Shellfish, Clams</u>: When used in the context of this Ordinance, the words "shellfish" and "clams" mean softshell clams, Mya Arenaria.
- D. <u>Municipality</u>: Refers to the Town of Freeport, Maine.
- E. All flats bordering the Wolf's Neck State Park as of December 8, 1983 are now under the jurisdiction of the Freeport Shellfish Conservation Ordinance. Recreational digging in Wolf's Neck State Park will not require a recreational license.
- 6. LICENSING: Municipal Shellfish Digging License is required. It is unlawful for any person to dig or take shellfish from the shores and flats of this Municipality without having a current license issued by this Municipality as provided by this Ordinance.

A Commerical Digger must also have a valid State of Maine Commercial Shellfish License issued by the Department of Marine Resources.

- A. Designation, Scope, and Qualifications:
  - (1) Resident Commercial Shellfish License: The license is available to residents of the Town of Freeport and entitles the holder to dig and take any amount of shellfish from the shores and flats of this Municipality and reciprocating municipalities.
  - (2) Nonresident Nonreciprocating Commercial Shellfish License: The license is available to nonresidents of this Municipality and entitles the holder to dig and take any amount of shellfish from the shores and flats of this Municipality.
  - (3) Resident Recreational Shellfish License: The license is available to residents and real estate taxpayers of this Municipality and entitles the holder to dig and take no more than one peck of shellfish in any day for the use of himself and his family.
  - (4) Nonresident Nonreciprocating Recreational Shellfish License: The license is available to any person not a resident of this Municipality and entitles the holder to dig and take no more than one peck of shellfish in any one day for the use of himself and his family.

- (2) Nonresident Nonreciprocating Commercial: One-Hundred Fifty Dollars (\$150.00)
- (3) Resident Recreational: Ten Dollars (\$10.00)
- (4) License Fees will be waived for residents 65 years or older.
- D. <u>Limitation of Diggers</u>: Because the shellfish resources are limited and because a commercial or recreational digger can be expected to harvest a certain volume of clams per year, the number of diggers must be controlled. This number will vary from year to year depending upon estimates of the resource capabilities and management requirements consistent with good resource utilization. The following procedures will be followed to exercise the control:
  - (1) Prior to January 1 the Freeport Shellfish Conservation Commission with the approval of the Commissioner of Marine Resources will establish the number of commercial or noncommercial licenses to be permitted.
  - (2) The Shellfish Conservation Commission will notify the Town Clerk in writing prior to February 1 of the number of licenses to be issued. No reservation will be accepted by telephone.
    - (3) The Town Clerk shall issue commercial renewal and non-renewal licenses to residents and non-residents according to the following priority. Ten percent of the renewal and non-renewal commercial licenses shall be retained for non-residents during the period of issuance

have the convictions. The second suspension under this paragraph shall be for thirty (30) days; the third for one hundred and eighty (180) days; and the fourth and subsequent for three hundred and sixty-five (365) days.

- H. <u>Surrender of License</u>: Any licensee may surrender his or her license and receive a refund of the fee paid, prorated for the remaining term of the license, and less a ten percent (10%) administrative fee. Any surrendered license shall be reissued in a manner consistent with State law and subsection 6(D)(3) of this Ordinance.
- - (1) The Town Clerk shall designate an assistant, who may be any appointed municipal official or municipal employee who is disinterested in the outcome of the procedure. "Disinterested" means not related by blood, marriage or adoption to any of the applicants and not having a direct or indirect pecuniary interest in the outcome of the procedure. No elected municipal official and no member of the Shellfish Conservation Commission shall serve as the Clerk's assistant in carryout this procedure.
  - (2) The Clerk shall prepare a list of the names of the qualifying applicants; the list need not be in any particular order. Next to each name on the list, the Clerk shall enter a unique three digit number, selected at random, and shall write each such number on an index card. All the index cards shall be of uniform size, color and texture.
  - (3) The Clerk's assistant shall then place all the <u>numbered index cards in a box or other</u> <u>container capable of being closed and</u> <u>suffuciently large that the index cards can be</u> mixed by shaking the container.

FINES: Any person harvesting shellfish in an area closed for conservation shall be subject to the following:

1. <u>First Offense</u> - dumping of shellfish; 10 days loss of Town License - \$50.00 Fine

2. <u>Second Offense</u>- dumping of shellfish; 20 days loss of Town License - \$100.00 Fine

- 3. <u>Third Offense</u> dumping of shellfish; 30 days loss of Town License - \$200.00 Fine
- 4. <u>After the third offense</u>, licensee must appear before the Shellfish Commission before license can be returned.

Offense period runs from April 1st to March 30th.

### SECTIONS DEALING WITH MINIMUM LEGAL SIZE OF SOFT SHELL CLAMS AND METHOD OF DETERMINING TOLERANCE

A. <u>Minimum Legal Size of Soft Shell Clams</u>: It is unlawful to possess soft shell clams less than two (2) inches in length. The tolerance is listed below:

- 1. <u>Tolerance</u>: Any person may possess soft shell clams that are less than two (2) inches if, beginning on the effective date of this article, they comprise less than 10% of any bulk pile; and beginning in calendar year 1986, they comprise less than 10% of any bulk pile. The tolerance shall be determined by numerical count of not less than one (1) peck nor more than four (4) pecks taken at random from various parts of the bulk pile or by count of the entire pile if it contains less than one (1) peck.
- 2. <u>Method of Determining Tolerance</u>: The tolerance is determined by a one (1) peck measure of a "LOT". The word "LOT" as used in this Ordinance means the total number of soft shell clams in any bulk pile. Where soft shell clams are in a box, barrel or other container, the contents of each box, barrel or
