RULE CHANGES

FEBRUARY 1994

1. Harb Cottage Rule #8
"...Groups of Larger than 250 100 people total are subject to approval by the Winslow Park Commission."
2. Harb Cottage Rule # 8c.:
"Tenant must provide additional portable toilets at the rate of 2 portable toilets per each [125] 100 people. For example ~~51-125~~ 51-100 people will require 2 portable toilets. ~~126-250 people will require 4 portable toilets.~~ All necessary arrangements and any costs incurred for acquiring portable toilets shall be the direct responsibility of the tenant and not of Winslow Park."
3. Shore Sites 1-5 shall be utilized for day use only as small group picnic areas. The maximum number of persons allowed on each site is 6. Maximum number of vehicles per site is 2. Multiple sites may be rented by the same person/group. Rental fee is \$10.00 per day per site plus regular per person entrance fee. Sites are subject to same rules and conditions as large group sites.
4. Camp sites 95, 97 & 99 shall be utilized as wilderness sites. No vehicles allowed on these sites. Vehicles shall be parked in a designated parking area within the park.
