FIRST ORDER OF BUSINESS: To waive the reading of the Minutes of Meeting #16-94 held on July 19, 1994 and accept the minutes as printed.

MOVED AND SECONDED: To amend the Minutes of Meeting #16-94 held on July 1994 on page 1 to add Councilor Mann to the roll; on page 6 under Item #130-94, correct vote to 2 Guimond - Bradley, Wold; on page 3 to correct the motion to read " to terminate this council meeting by 11:00 P.M", and accept the minutes as amended. (Councilors Campbell & Mann) (6 Ayes) (0 Nays)

SECOND ORDER OF BUSINESS: Public Comment Period - 30 Minutes.

1. Councilor Mann raised concern for a dangerous hole on the Burnett Road. He also stated he had talked with someone interested in bidding on the library furnace repair and that it is cheaper to do the work in the summer. He requested an update as to the status of this.

Manager Olmstead will include an update in the next Council packet and refer the Burnett Road problem to the Public Works Department.

2. Councilor Wold raised concern for the misinformation in a recent article in the Forecaster regarding a meeting held by the Winslow Park Commission which had been labeled "secret"; it was not a secret meeting.

Referencing quotes by Councilor Mann, he asked where in the Town Charter it is stated that a committee/commission person has to go through the Town Manager to speak to the staff person with whom they are dealing.

Councilor Mann stated that he had been misquoted - it is in the

Administrative Code.

**MOVED AND SECONDED:** THAT THE PROPOSED **AMENDMENTS TO THE FREEPORT ADMINISTRATIVE** CODE CONCERNING THE RECREATION COMMITTEE (CHAPTER 2) BE SUBJECT TO PUBLIC HEARING. (Councilors Bennett & Campbell) (6 Ayes) (0 Nays)

Chairperson Ruff reviewed the history of the Town's recreation committee. She stated that the proposed amendments are the result of a number of meetings with school officials, former members of the recreation committee, the Council and the Appointments Comittee. She described the proposed functions of this committee.

Peter Moulton recommended eliminating Section E; eliminate reference to the ATL Committee in Section F. He added that he would prefer having a Parks and Recreation Department, separate from community education.

Mary Kennedy suggested using a different word in Section C other than "support". She asked who would be setting the guidelines for this committee.

John Forest stated he is pleased the Council is working on this. He asked which department would be in charge of this committee, the school or the Town.

Peter Moulton stated that presently, the Recreation Director is under the control of the School Board.

Councilor DeGrandpre suggested, re: Section I, deleting Wolf Neck Farm from the list of committees. She stated that she feels the Recreation Committee should support any deficiencies they see in the Town. She stated she feels Section E should remain. She stated that the Council should make the guidelines for this new committee.

Councilor Campbell stated he agrees with keeping the entities separate.

i.e., (the recreation committee and the school department).

Councilor Wold recommended that under Establishment, the paragraph read, "There shall be a recreation committee, consisting of 7 members, who shall all be residents of the Town of Freeport, appointed by the Town Council". Under duties, he recommended eliminating the word "all". He suggested that if there were a need to change the word "supporting" under Sections C and F, "considering" could be used. He stated he prefers to omit reference to ATL's in

this document.

Councilor Mann thanked Mr. Moulton for his efforts in working on this project. He raised concern for reducing the recreation from a department head level to the status of a committee. He stated that re: Section E, he does not think it is the intent for this committee to review subdivisions.

Chairperson Ruff reviewed the history of recreation, community education. She stated that more funding was available for recreation and community education activities if coordinated through the school, etc. She stated that it makes sense to run all the Town programs under "one roof". She added that the intent of community education is to be community wide, including all of the needs in the community. She stated that at this time, she could not support a separate recreation committee that ran programs which the council would have responsibility for. She stated that she does not feel the verbiage is mandating anything, i.e., Sections C, E and F.

Councilor Wold stated that it sounds to him that they are creating a

"recreational facilities committee".

Chairperson Ruff stated that she sees Section A as a planning piece. She stated she sees this as a group looking at needs, doing some fund raising, etc.

Mary Kennedy stated that senior citizens in Town are underserved in terms of recreation.

Chairperson Ruff stated that Tom Nash, Director of Community Education, was supportive of the charge to this committee.

Manager Olmstead was requested to procure a list of activities available for senior citizens.

MOVED AND SECONDED: THAT THE PUBLIC HEARING BE CLOSED. (Councilors Campbell & Bennett) (6 Ayes) (0 Nays)

## 1. REPORT ON PLANNING BOARD ACTIVITIES.

John Creasy, Planning Board member, reported on the Board's activities: Over the last 2 months, re: public hearings held and action taken, were the amendment to exempt pump stations from space standards and setbacks, approval of the site plan for Freeport Middle School basketball court and ice rink, approval of the site plan for Larry Greenlaw at 128 Main Street and approval of L. L. Bean at Desert Road to plan for their expansion.

He stated that continuing items include: the Gap expansion, the ball field at Mast Landing School, and the zoning change request of Mr. Bennett to allow commercial marine fisheries in MDR-1.

2. DISCUSSION ON POSSIBLE INSTALLATION OF TRAFFIC LIGHTS. (MAIN STREET/MALLETT DRIVE AND MAIN STREET/WEST STREET).

Councilor Bennett gave an overview of the study done regarding 4 intersections on Main Street; with further discussion, the Traffic and Parking Committee felt the need for traffic lights at Main Street and Mallard Drive, and Main Street and West Street.

David Thompson, Traffic and Parking Committee member, described the conditions at these intersections, currently, without traffic lights.

It was decided to instruct the Manager to put this item on a future agenda for public hearing.

- 6. Councilor Campbell stated that concerns have been brought to him for an additional crosswalk on South Street by the retirement village and driveways being blocked on side streets during the summer months.
- 7. Chairperson Ruff requested that councilors bring any council goals/concerns to the next meeting.
