1. Wayne Hollingworth reviewed the issues brought up at the last regular Council meeting. He stated that it is the feeling of the Commission that the user fees are an important part of the park's income; the park is "in the black", but needs to continue to be; a number of improvements have been made without Town subsidies, etc., they maintain the Town road, boat ramp, etc. He stated that the Commission has been frugal and has tried to maintain this. He stated that Freeport school children will get in free (a change to the fee schedule), and the fee for group areas is \$100.

Councilor Wold stated that the proposed fee schedules will enable the Commission to make the improvements for handicap accessible bathrooms and improvements to the playground.

Discussion followed re: seasonal camping fees, Harb Cottage usage, pre and post season usage, date to approve fee schedule, clarification on the fee schedule, that clam diggers are not charged for usage, etc.

Councilor DeGrandpre moved (informally) that the seasonal camping resident fees stay at \$675, that the Harb Cottage weekly rates from July 1 through Labor Day for the Freeport residents remain at \$800 and the pre and post season weekly rates stay at \$600, including utilities for Freeport residents.

Chairperson Ruff stated that she wished to commend the Landfill for their efforts in making the landfill available on two weekends to take all the trash; she is in hopes that the Council will consider doing this again next year.

2. REPORT ON BOW STREET.

Manager Olmstead provided an update on the Bow Street Project; re: trees he stated that several trees had been cut; there is money in the Budget to replace some of them; he will be applying for grant funds to provide enhancements in the area. Re: the speeding issue - he stated he had talked with Chief Schofied and Michael Whitehouse, who have committed to do what they can to monitor the speed on Bow Street, request for street lettering in the school zone and procure additional signage. He stated that he had met with Alden Small, requesting that MDOT increase their commitment to the project by some \$28,000. Re: paving and sewer responsibility for that paving, Manager Olmstead stated he had talked to Tom Allen of the Sewer District, who assured that in areas where they removed pavement to install the sewer line outside of the project area, they did repave and pay for that, but did not pay for any new overlays where the pavement was removed because of the overall project. As far as putting a new overlay on that section from Dennison to Lower Mast Landing Road, once the project is complete, a request has been made to the State to pave that section in the Spring. The State has agreed to review the area at project completion. He stated that Peter Tubbs said the project is near completion and Peter is recommending one addition to the budget, an estimated \$200 - \$300, to do additional work to Janet O'Brien's driveway, to try to improve that situation - this will be eligible for cost sharing.

Councilor Bradley requested that Peter Tubbs speak with the residents on the downside slope of the project area.

Discussion followed re: striping on the road, driveway improvement funding, question of use of Town grader (used in conjunction with sewer).

John Forrest raised concerns re: road patches, trees and his water pipe.

Janet O'Brien reiterated her concern for safety, re: her driveway.


