Library parking lot during certain weekends in the summer when the Library is closed.

Discussion followed re: use of temporary permit, location of tent, revenue for the

Town, the Library personnel's acceptability of this, etc.

MOVED AND SECONDED: That Mr. Maxwell's request to use the Library parking spaces to fulfill his parking requirements during the weekends outlined in his memorandum to the Town Manager be approved. (Councilors Wold & Bennett) (6 Ayes) (1 Nay - Mann)

2. DISCUSSION ON PLANNING BOARD RECOMMENDATION TO FORM A COMMITTEE TO STUDY U.S. ROUTE 1 SOUTH ZONING.

David Thompson reviewed the Planning Board's recommendation.

Discussion followed re: the make-up of this committee, the Planning Board's work load schedule, etc.

3. DISCUSSION ON VILLAGE COMMERCIAL I ZONING LINES.

Manager Olmstead stated that this represented discussions the Council has had, whether or not the Council should recommend to the Planning Board that after they get through the process of reviewing individual zoning requests for amendments to the VC I zoning line, whether or not they ought to take a comprehensive look at the zone and bring forth additional changes, if appropriate.

Councilor Ruff stated that there are major areas to be looked at again and look throughout the community and how they evaluate requests.

Councilor Wold suggested planning a joint workshop with the Council and the Planning Board.

Councilor Bennett stated that he has concerns with how "neighborhood" is now defined.

David Thompson stated that the Planning Board does have on the agenda, per Council request, to start the discussion of scheduling public hearings to amend the Comprehensive Plan; he felt that this would be a good opportunity to do some long-term planning.

Barbara McGivaren requested that the Council review the traffic and parking study that L. L. Bean's has had done.

4. DISCUSSION ON PROPOSALS FOR A LEASE APPRAISAL FOR THE LIBRARY BUILDING.

Manager Olmstead, on request of the Council, solicited proposals for a lease appraisal for the Library building; he reviewed the 3 received - Mid-Coast Appraisal Service, Appraisal Associates and Gosline and Company.

Councilor Wold asked if there was the potential for conflict of interest.

Councilor Ruff questioned the price differences.

Manager Olmstead stated that the information to be used for this appraisal is in the Assessor's Office, and the project could be done in-house, but by using a company to perform the service, it would represent an independent point of view.

Councilor Mann stated he is satisfied with the results they already have and does not support hiring an outside consultant.

Councilor Bennett stated he agreed with Councilor Mann.

Councilor Wold stated that by seeking an independent party to do this, the voters would have a package to vote on.

MOVED AND SECONDED: To engage the firm of Mid-Coast Appraisal Services to do a lease appraisal on the Library building. (Councilors Wold & Bennett) (6 Ayes) (1 Nay - Mann)

5. DISCUSSION ON LEGISLATIVE INITIATIVES.

Manager Olmstead gave an overview of the proposed L.D. 1217, the "takings" bill. Alison Truesdale raised her personal concerns regarding this bill, the Town being subjected to lawsuits, potential increases in taxes to pay for legal fees, etc. She added that there are some very big lobbying groups backing this.

Councilor DeGrandpre stated that MMA is against this bill.

Councilor Ruff suggested that they send someone to represent the Town to the workshop on this.

Councilor Mann stated that he feels there are parts of this proposal which have merit.

Manager Olmstead stated that if Freeport has a position on this, someone needs to attend the workshop.

Discussion followed re: drafting a statement, etc.

MOVED AND SECONDED: That the Chair and the Manager compose a letter to be read at the hearing by Ms. Truesdale or one of the councilors. (Councilor Ruff & DeGrandpre) (no formal vote taken)

Discussion followed re: the pros and cons of the bill. (The majority of the Council agreed to draft the statement.)

MOVED AND SECONDED: That the Planning Board be ordered to work with the Town Attorney to clear up any legal issues and clarify Section 203 of the Zoning Ordinance. (Councilors Mann & Bennett) (7 Ayes) (0 Nays)

Should James Gorman be successful in acquiring property from Peter Van Campen located at 203-5 Main Street, (tax map 12/54), he agrees to sell a portion of said property to the Town of Freeport shown on attachment (Exhibit A).

Conditions of the sale as follows:

- 1. The Town of Freeport's ability to obtain zoning change or amendment, necessary to construct a municipal facility and subject to final site plan approval.
- 2. Mr. Gorman will allow agents for the Town to do appropriate test borings on the property necessary for zoning changes.
- 3. Subject to voter approval of project on November 7, 1995.
- 4. Purchase price will be \$110,000.00, with each party paying their respective closing costs.
- 5. Subject to survey.
- 6. Mr. Gorman reserves the right to donate the buildings to the Town of Freeport or the Freeport Housing Trust should the house remain on the parcel purchased by the Town.
- 7. The Town recognizes that the 5 acres to be retained by Mr. Gorman is a lot that should accommodate at least one dwelling under current zoning. This assumes that ownership of the 50'

Right of Way is retained by Mr. Gorman and ownership of the 5 acre lot will be in a different name from the existing house lot.

8. The Town agrees to remove approximately 20 trees from the Lower Pleasant Street right of way to the property.

ROLL CALL VOTE (Councilors Ruff & Bennett) (7 Ayes) (0 Nays)

Councilor Mann stated that this contract gives the Town the right to back out of the agreement for many reasons, such as failing to get a zone change amendment, site plan approval and/or test borings necessary for the zone change. This agreement is also contingent on voter approval and land survey.

6. MANAGER'S PRESENTATION OF THE PROPOSED FY 96 OPERATING BUDGET. Manager Olmstead provided an overview of the proposed fiscal year 96 operating budget, the budget workshop schedule, the executive summaries, the Winslow Park budget, the Options List and the Appropriation Control Report. He pointed out the items which represented major changes and why they occurred.

7. LANDFILL CLOSURE COSTS.

Manager Olmstead reviewed a proposal from Shaw Brothers to close the Old Freeport Landfill at a unit cost of \$.77 per square foot. He stated that the Town would save in the closure cost and also the cost for engineering, if they accept this proposal. He requested putting this on the next agenda for formal approval.

8. Chairman Campbell stated that he has asked Councilor Wold to chair the Fire/Rescue restructuring committee.
