Manager Olmstead stated that the closing will be taking place in a month. He stated that they need to determine what they are going to do with the property, both short and long term. He suggested putting up a couple of signs, "Property of the Town of Freeport", and appointing a committee to work on this.

Discussion followed re: make-up of the committee, signage, writing a charge for this committee, wholesale clam diggers being able to use the property, etc.

Dick Merrick volunteered to serve on this committee.

Greg Wiley referenced a proposal he has submitted for use of the building.

- 3. Councilor Mann suggested soliciting either bids or contracts to get a commitment in time for the November election, re: the library project.
- 4. Councilor Wold stated that the Council needs to put on an agenda before the budget is approved, to approve Winslow Park going to a December fiscal year.
- 5. Councilor Bennett asked for clarification of the Harrasseket Yacht Club letter.

 Manager Olmstead stated that this is a restatement of their policy which has been in place for the last four years.
- 6. Councilor Campbell suggested that the budget workshops be postponed until the State funding numbers have been determined.

Manager Olmstead stated that the workshops can be rescheduled until the following week and delay the budget vote until the 27th of June.
