#### **OUESTION 1**

SHALL THE TOWN OF FREEPORT APPROVE THE FOLLOWING PROPOSED APPROPRIATION ORDINANCE FOR UP TO \$415,000 BE SUBMITTED TO THE VOTERS OF THE TOWN OF FREEPORT AT THE SPECIAL MUNICIPAL ELECTION ON MARCH 5, 1996.

THE TOWN OF FREEPORT HEREBY ORDAINS: THAT A SUM NOT TO EXCEED \$415,000 IS HEREBY APPROPRIATED FOR THE PURPOSE OF PURCHASING A FIRE LADDER TRUCK. TO MEET SAID APPROPRIATION, THE CHAIRPERSON OF THE TOWN COUNCIL AND THE TOWN TREASURER ARE AUTHORIZED TO ISSUE GENERAL OBLIGATION SECURITIES OF THE TOWN OF FREEPORT IN A TOTAL PRINCIPAL AMOUNT NOT TO EXCEED \$415,000 AND THE DISCRETION TO FIX THE DATE(S), OF PAYMENT, FORM(S), AND OTHER DETAILS OF SAID SECURITIES, INCLUDING EXECUTION AND DELIVERY ON BEHALF OF THE TOWN OF FREEPORT, AND TO PROVIDE FOR THE SALE THEREOF, IS DELEGATED TO THE CHAIRPERSON OF THE TOWN COUNCIL AND THE TOWN TREASURER.

#### EXPLANATION AND RECOMMENDATION

THE FIRE DEPARTMENT LADDER TRUCK IS A 1982 MODEL AND WAS PURCHASED BY THE TOWN IN 1988. THE TRUCK IS CURRENTLY IN DISREPAIR AND NEEDS EXTENSIVE RUST AND BODY REPAIR. AN INDEPENDENT CONSULTANT HAS INSPECTED THE CURRENT LADDER TRUCK AND HAS DETERMINED THAT THE VEHICLE CANNOT BE COST-EFFECTIVELY REHABILITATED.

THE FIRE DEPARTMENT AND THE TOWN COUNCIL SUPPORT THIS REQUEST

**BE IT ORDERED:** THAT THE APPROPRIATION ORDINANCE SUBMITTED TO PUBLIC HEARING ON JANUARY 2, 1996 BE SUBMITTED TO THE VOTERS OF THE TOWN OF FREEPORT AT THE SPECIAL MUNICIPAL ELECTION OF MARCH 5, 1996.

TO MEET SAID APPROPRIATION, THE CHAIRPERSON OF THE TOWN COUNCIL AND THE TOWN TREASURER ARE AUTHORIZED TO ISSUE GENERAL OBLIGATION SECURITIES OF THE TOWN OF FREEPORT IN A TOTAL PRINCIPAL AMOUNT NOT TO EXCEED \$185,000 AND THE DISCRETION TO FIX THE DATE(S), OF PAYMENT, FORM(S), AND OTHER DETAILS OF SAID SECURITIES, INCLUDING EXECUTION AND DELIVERY ON BEHALF OF THE TOWN OF FREEPORT, AND TO PROVIDE FOR THE SALE THEREOF, IS DELEGATED TO THE CHAIRPERSON OF THE TOWN COUNCIL AND THE TOWN TREASURER.

#### **EXPLANATION AND RECOMMENDATION**

THIS TRUCK IS ONLY 13 YEARS OLD WITH ONLY 21,000 MILES. THIS AUTHORIZATION REPLACES A PARTIALLY OPEN CAB WITH A NEW FULLY ENCLOSED AND NEW BODY.

AN INDEPENDENT CONSULTANT HAS INSPECTED AND DETERMINED THE ENGINE, TRANSMISSION, DRIVE TRAIN, SUSPENSION, FRAME RAILS, ETC. ARE GENERALLY SOUND AND HAVE A BETTER THAN AVERAGE PROBABILITY FOR PARTS AND SERVICE FOR ABOUT 10 YEARS.

THE AERIAL LADDER IS TESTED YEARLY BY AN INDEPENDENT TESTING FIRM AND CERTIFIED TO BE SAFE, IF USED PROPERLY, TO DESIGN SPECIFICATION.

THE TOWN COUNCIL SUPPORTS THE REQUEST.
