Manager Olmstead explained that it had been discovered in prior years that there is a law which allows communities to charge a service fee to non-profit organizations which had properties used to generate profit and compete with the private sector. This law gives communities an

opportunity to charge an assessment for the municipal services rendered, i.e., fire, rescue, police, etc. We would be able to assess these properties in the 4.5 mil range; this would take effect in the next assessment year.

Councilor Mann asked what properties could be affected.
Manager Olmstead stated he would provide this list.
Councilor Hindley asked for clarification of tax amounts.

Andrew Arsenault raised concerns for the effect of private property and consultants used in the past.

Discussion followed re: timeframe for work to be done, needs of updating information, risk of private property, etc.

Councilor Campbell offered his support for this application.

estimated \$900.00, a leak in the Town Hall roof, and the former school department space at Town Hall.

Manager Olmstead stated that the roof has been leaking since 1990. Estimates for repair ranged from \$500 to \$11,000; this would be looked into further.

3. DISCUSSION ON PROPOSED IMPROVEMENTS TO HOWARD PLACE PARKING LOTS.

Manager Olmstead reviewed the efforts to date; there will be an actual gain of twenty-four spaces and improved traffic flow, etc. He proposed that the Town coordinate the improvements if the Council approves, thus making available to the project, C.O.G.'s bid prices on materials; the Council's role is basically to vacate Old Main Street easements and to agree that the town could coordinate the project.

Michael Marino provided an historic overview of the location, the need for a parking lot, etc.

The architect described the concept; he stated he has talked with L. L. Bean, Peter Tubbs and the merchants, to assure that all things are taken into consideration.

Discussion followed re: traffic problems, storm water run-off system, short an and long-term effect to the library, time table for construction, etc.

Manager Olmstead stated that the Council needs to decide to start the project, allow him to coordinate the project and abandon the section of Old Main Street currently owned by the town.

Discussion followed re: town's involvement, funding, library parking, going to the Planning Board to have the site plan approved, etc.

4. DISCUSSION OF JUNE, 1996 INFORMATIONAL REFERENDUM OUESTIONS.

Manager Olmstead provided a draft of the informational sheet; he proposed to use the town's bulk mailing permit to send the letter to the voters, prior to the primary election.

Chairperson DeGrandpre raised questions about the school bus.

Miscellaneous discussion followed.

5. PRESENTATION OF FISCAL YEAR 97 OPERATING BUDGET.

Manager Olmstead reported on the budget process, revenue
based budgeting, etc. The new property tax revenue would be
\$518,028, the tax revenue would be shared: 62% for the
school department and 38% for the municipal side of
government. Lost revenue from non-property tax was
deducted. He explained the user fees and tipping fees.

There will be a reduction in estimated revenue from building permit fees and a reduction in lease payments from the State; thus, we will be losing \$16,690, leaving \$180,000 to spend on municipal adjustments.

Because of the way he is budgeting RWS expenses, debt service increases by \$69,000, because RWS will assess a dept service fee to each community.

The municipal side will also absorb an increase in the Agency budgets of \$60, a County tax increase of \$21,000 and RWS debt increase of \$69,455, totaling \$90,703. Thus, the dropped to \$89,457. The department heads were informed as to what they could spend to keep within the budget figures. The municipal budget is up by an estimated 2%. Manager Olmstead described how the \$89,457 would be spent; a new Rescue Chief - \$28,000, Economic Development - \$24,000, absorption of utility costs on West Street - \$9,000, employee buyout, and an increase of \$5,000 for public restrooms.

Miscellanous discussion followed.

6. CONSIDERATION OF AN EXECUTIVE SESSION WITH THE TOWN ATTORNEY TO DISCUSS POTENTIAL LITIGATION.

Manager Olmstead stated he does not feel he can put on the agendas items for which the Council has no jurisdiction.

Council Mann stated he would like an opinion from an independent attorney, re: Tidewater Trust abatement.

Councilor Campbell stated he would rather rely on expertise of legal counsel.

Councilor Hindley stated he would rather avoid litigation.

618.1 ESTABLISHMENT

ONE PLANNING BOARD MEMBER SELECTED BY THE PLANNING BOARD AND TWO

The Community Relations Committee shall consist of nine members. The membership shall include three members appointed by the Freeport Merchants Association and three members at large appointed by the Freeport Town Council, each serving for staggered three year terms. Three Town Council members, appointed by the Town Council Chairperson, shall serve for one year terms. Residency requirements shall only apply to those members appointed by the Town Council. Should a permanent vacancy occur, the appointing body shall within sixty (60) days of its occurrence, appoint a person to serve for the unexpired term. The Committee shall elect from its membership, a Chair and a Vice-Chair.

The Chairperson shall establish a meeting schedule for the Committee. The Committee shall meet at least quarterly. A quorum of the Committee shall be required to conduct business, and a quorum shall consist of at least five (5) members. The vote of a majority of the members present at a meeting at which a quorum is present shall be the act of the Committee.

618.2 DUTIES AND RESPONSIBILITIES

The Community Relations Committee shall be advisory to the Town Council.

The Committee shall Be responsible for the following:

- 1. Develop and promote cooperative efforts and issues of interest between the Town and the Business Community;
- 2. The development and recommendation of an Economic Development Strategy for the Town. All proposals involving the comprehensive plan or zoning shall be forwarded to the planning board for consideration;
- 3. Consider, coordinate and prioritize requests for improvements to the community;
- 4. Promote open lines of communication between and among the Merchant Community, Town Officials and Citizens of the Town of Freeport;
- 5. Meet on an annual basis with the Freeport Merchants Association, the Freeport Town Council and Planning Board to report on Committee activities and solicit input.
