1. DISCUSSION ON REQUEST OF USE OF TOWN HALL GROUNDS FOR OCTOBER 12, 1996 "FOURTH ANNUAL GREAT CHOWDAH CHALLENGE."

Chairperson DeGrandore reviewed the letter received from Elizabeth Finlayson. Director of Freebort Community Services. There were no objections to this event taking place.

2. REPORT OF MEETING WITH STANDISH AND BUXTON CONCERNING PROPOSED MDOT ROAD TURN BACK. (REVIEW DRAFT LETTER TO COMMISSIONER MELROSE)

Chairperson DeGrandpre reviewed the draft letter to Commissioner Melrose. She stated that she, Councilor Hindley and Manager Olmstead attended a meeting in Standish regarding this issue.

Councilor Hindley stated that the goal was to make a joint effort with these

towns faced with the turnback situation.

Chairperson DeGrandpre stated that Gray-New Gloucester have reached the 4,000 (population) threshold and have been notified by the State that they will be responsible for winter maintenance on their roads. The issue involves more that these types of towns; towns such as Scarborough, Yarmouth, etc., which have already had roads turned back to them can be reevaluated by the State for further turnbacks; we are trying to rally all of the surrounding towns because of the problems arising from this - what is the definition of a "good road" and also the fact of increasing town budgets. Discussion followed re: responsibility for major reconstruction, definition of "maintenance", report from Peter Tubbs, the State's expectations of the

Chairperson DeGrandpre referenced the third paragraph in the draft letter which raises the question of "maintenance"; Manager Olmstead will provide

further information on this.

Councilor Mann, re: the second paragraph, stated that one of the things we are trying to get our State representatives to do is change the laws. Chairperson DeGrandpre stated that the chances for changing the laws in time are slim.

It was mutually agreed to send out the letter to the Commissioner.

3. DISCUSSION ON THE ADVISORY NOVEMBER REFERENDUM **QUESTIONS - SOLID WASTE & RECYCLING COMMITTEE** Katherine Bither, Chairperson Solid Waste Committee, provided an overview of efforts to date of the Committee to study the "pay-per-bag" or incentive based system and to make recommendations to the Council. She stated that there are basically two parts to the solid waste management cost to taxpayers to consider; one is the actual collection of the waste from homes and the tipping fees at RWS. Currently, the tipping fee is in the tax base and individuals pay for the collection cost. What has happened is that the tipping fee has increased from an estimated \$50 per ton to \$98 per ton, which would double the budget amount. The Committee felt that a pay-perbag system is fair, but for families (large families, elderly) which would be impacted by this, costs would be high. Establishing a transfer station would offset these costs. The Committee does not recommend putting on the ballot at this time, the pay-per-bag question, due to lack of time to educate the people on this issue.

Tom Bull, Recycling Committee, stated that we have been struggling with this issue for a long time; we want to find out what the people want to do regarding this issue; this is not the right time to deal with this issue.

Ms. Bither stated that there are many ways to deal with this issue,

personalizing it to Freeport's needs.

Discussion followed re: increase in RWS fees, seeking ways to decrease these costs, recycling, commitment to RWS, preserving the free enterprise system, the proposed ballot questions being non-binding, possibility of figures in the questions being misleading, etc.

Planner Cohen clarified that there was an amendment to the question, re: issue of a single hauler, "a single hauler system does not guarantee a

reduction in cost".

Ms. Bither stated that for the Committee, she has talked with ten to fifteen communities on these issues; in general, she has found that many other communities that have collection costs from \$.60 to \$1.00 a pick-up per household. She has also researched the ranges of total cost of solid waste per household; the ranges for an annual cost are from \$77 per year to \$200; we are paying about \$200 per year per household for the collection and tipping fee.

Concensus: 4 councilors prefer to keep the April 2, 1996 wording, leaving

the dollar amounts in.

4. Councilor Beaulieu reported that the signage change on #95 for the Freeport downtown exits has been completed.

COMMITTEE REPORTS: ORDINANCE COMMITTEE - COUNCILOR CAMPBELL Councilor Mann stated that they have sent to the Council the ordinance which proposes the new committee for exploring historical sites, recording/updating maps, etc., which has been mandated by the Comprehensive Plan.
