TO MEET SAID APPROPRIATION, THE CHAIRPERSON OF THE TOWN COUNCIL AND THE TOWN TREASURER ARE AUTHORIZED TO ISSUE GENERAL OBLIGATION SECURITIES OF THE TOWN OF FREEPORT IN A TOTAL PRINCIPAL AMOUNT NOT TO EXCEED \$450,000.00 AND THE DISCRETION TO FIX THE DATE(S), MATURITY(IES), DENOMINATION(S), INTEREST RATE(S), PLACE(S) OF PAYMENT, FORM(S) AND OTHER DETAILS OF SAID SECURITIES, INCLUDING EXECUTION AND DELIVERY ON BEHALF OF THE TOWN OF FREEPORT, AND TO PROVIDE FOR THE SALE THEREOF, IS DELEGATED TO THE CHAIRPERSON OF THE TOWN COUNCIL AND THE TOWN TREASURER.

EXPLANATION AND RECOMMENDATIONS:

THE TOWN OF FREEPORT HAS SOUGHT ADDITIONAL RECREATION SPACE FOR SEVERAL YEARS. RECOGNIZING THAT AS THE TOWN'S POPULATION GROWS, THE UTILIZATION OF EXISTING SPACE HAS BEEN MAXIMIZED AND SUITABLE TRACTS OF LAND ARE NOT READILY AVAILABLE IN THIS TOWN. THE RECREATION COMMITTEE UNANIMOUSLY RECOMMENDS THAT THE CITIZENS OF FREEPORT BE OFFERED THE OPPORTUNITY TO PURCHASE LAND FOR AN OUTDOOR RECREATIONAL FACILITY.

A POTENTIAL SITE HAS BEEN IDENTIFIED, WHICH IS LOCATED ON THE UPPER MAST LANDING ROAD, AND CONSISTS OF 39 ACRES (TAX MAP 20 LOT 2). THE SITE APPEARS TO SATISFY MANY OF THE NEEDS IDENTIFIED IN THE COMPREHENSIVE PLANS, INCLUDING HIKING TRAILS, PICNIC AREAS, CONSERVATION AREAS, OPEN SPACE FOR PLAYING FIELDS AND COULD PROVIDE AN ALL SEASON SITE ACCESSIBLE TO A MAJORITY OF FREEPORT RESIDENTS.

FURTHER ANALYSIS OF THIS SITE IS NEEDED AND BOTH STATE AND LOCAL PERMITS MUST BE OBTAINED. SHOULD THE SITE NOT MEET THE RECREATIONAL NEEDS OF THE TOWN OR PERMITS CANNOT BE OBTAINED, THE RECREATION COMMITTEE WILL PURSUE OTHER POTENTIAL SITES. A TOWN COUNCIL VOTE WILL BE REQUIRED BEFORE ANY SITE IS ACQUIRED.

THE RECREATION COMMITTEE IS PARTICULARLY INTERESTED IN PROMOTING PARTNERSHIPS BETWEEN THE TOWN AND CITIZEN GROUPS TO DEVELOP A TOWN RECREATION FACILITY.

(Councilors Beaulieu & Campbell)

Councilor Campbell stated that he supports this item going to the voters for approval; should the voters support this, that would give us the approval to actively seek and secure a piece of property. This is the result of much debate and consideration by the Council.

Bob Lowell asked for clarification of the Public Hearing process and the wording on the ballot.

Manager Olmstead explained the public hearing procedure; he stated that tonight was the vote of whether or not to place this item on the ballot; the purpose of the Public Hearing on October 15th is to debate the merits of the referendum question.

Mr. Lowell agreed that this item should go to the Town voters to decide; he requested clarification of the wording for the ballot.

John Hoy, Recreation Committee, stated that there has been a need to address the question; the Recreation Committee agrees that this item should be on the November ballot.

Councilor Mann stated that he had been "flooded" with questions regarding this issue.

John Hoy explained that the intent of the \$450,000 included purchase of land, development of the land up to a certain level, including playing fields, baseball fields, soccer fields, tennis courts, basketball court, parking, picnic tables, etc.

Councilor Hindley questioned the cost of developing the property.

John Hoy stated that negotiations are in process, but cost is not clear yet.

Councilor Mann stated that he has a problem with the language of this item; there is no breakdown of the costs involved; he added that he would prefer more backup information available in order to make a decision.

Miscellaneous discussion followed re: this item being framed the way it was intended to be framed, clarification of costs involved (discussed in executive session), not delaying this issue for another year, etc.

Horace Gower, Recreation Committee, stated it is important to hear what the voters want; with authorization, we can proceed; we do have realistic figures in mind; we have evaluated an estimated 17 properties for a location; we have enough information to move forward with the voters' approval.
