PROPOSED AMENDMENT ADMINISTRATIVE CODE (CHAPTER 2)

SECTION 405 - SHELLFISH PROGRAM COORDINATOR

- 1. Establishment and Appointment. The Town Manager shall appoint a Shellfish Program Coordinator: which shall be a part time position.
- 2. Duties. The Shellfish Program Coordinator shall be responsible for establishing and managing a shellfish management program which shall include water testing, flat surveys and other local and state requirements. The Shellfish Program Coordinator shall act as a liaison with the Departments Marine Resources of Environmental Protection and coordinating with DEP on overboard discharge issues.
