Mr. Olmstead indicated that Reid Potter would be reporting on the bid submittals. Mr. Potter advised that he reviewed the bids submitted by contractors. CPM Constructors of Freeport was the low bidder and he has reviewed their bid carefully. He feels it is a good bid but dredging is excluded. The dredging cannot be done until after the wharf is complete. He answered questions for Councilors. He recommends that a performance bond be required. Councilor Mann suggested that Mr. Potter contact the Coastal Waters Commission to see what they are considering. Mr. Potter agreed to contact them. Mr. Olmstead suggested that the Council have a workshop with the Coastal Waters Commission and decide what needs to be done.

MOVED AND SECONDED: THAT THE BID FROM CPM CONSTRUCTORS IN THE AMOUNT OF \$258,450 FOR THE REPLACEMENT OF THE TOWN WHARF BE ACCEPTED.

**BE IT FURTHER ORDERED:** THAT THE TOWN MANAGER BE AUTHORIZED TO SIGN CONTRACTS.

**BE IT FURTHER ORDERED:** THAT THE DREDGING COMPONENTS OF THIS BID REMAIN AS OPTIONS TO BE DETERMINED BY THE COUNCIL AT A LATER DATE.

Councilor Mann pointed out that he fully supports this application but feels a public hearing process is needed. Chair Beaulieu indicated that she normally would feel the same but the citizens of Freeport have already voted on this issue and indicated that they want this done.

### **OTHER BUSINESS:**

### 1) LIBRARY BUILDING COMMITTEE

Councilor Campbell advised that everything is going well but they have run into more ledge than was anticipated. They have made preliminary adjustments to their spending commitments to compensate for the ledge problem. It appears that an error was made in estimating the amount of ledge that exists there. There are two more days of blasting anticipated. Pre blast surveys were done for the abutters. The foundation is fully installed. Councilor Mann raised the issue of fill being stockpiled on the Curtis Road and Wardtown Road and eventually it is to be returned to the Library site. Chair Beaulieu suggested that this issue be discussed this week and a report brought back to the Council. Councilor Campbe'l pointed out that a Library Building Committee meeting is scheduled for tomorrow night and everyone is welcome to attend.

Councilor Hindley inquired about the contract status with Teddy Bear. Mr. Olmstead advised that the attorneys are negotiating the contract now and he is hoping to have something within 30 days for the Council

2) DISCUSSION ON OFFER OF LAND FROM THE NATURE CONSERVANCY.

Tom Rumpf advised that he is trying to determine the amount of interest that the Town of Freeport may have on a certain piece of land donated to The Nature Conservancy. He is hoping that some clear indication of interest could be given immediately. Mr. Olmstead pointed out that both the Conservation Commission and the Recreation Committee are discussing this land. Mr. Soley pointed out that costs need to be determined to repair a dam that exists on the property. Chair Beaulieu suggested that the Council discuss this in their workshop with the Conservation Trust and the Recreation Committee that is scheduled for January 28, 1997. Mr. Rumpf pointed out that someone from the Conservancy could attend this meeting but he was hoping for some indication of interest before this. Mr. Campbell suggested that Chair Beaulieu communicate with both committees prior to the workshop and ask what their level of interest is in writing before the workshop.

3) REQUEST FOR THE USE OF THE TOWN HALL LAWN FOR A HOLIDAY ACTIVITY ON DECEMBER 13, 1996.

Chair Beaulieu pointed out that Santa will be here during Sparkle Weekend which is December 13, 14 and 15.

4). COUNCIL COMMITTEE ASSIGNMENTS FOR THE COMING YEAR.

Chair Beaulieu passed out the assignments. Everyone got the committees they asked for. She asked Councilor Mann to serve as the liaison to the Water District. She will be the liaison to Wolfe Neck Farm. Councilor Mann agreed to this request.
