George Fraser, Planning Board Member, reviewed the 10-3-96 memo to the Council regarding the evaluation of the zoning currently in effect in the C-I and C-II Districts. He stated that the Route One South Advisory Committee, appointed by the Council in September 1995, reviewed the Zoning Ordinance, developed the creation of a set of performance standards to act as a template for developers and various review boards, and a draft amendment to the Zoning Ordinance regarding the above zones, which will avoid "strip development".

Jackie Cohen, Town Planner, described development of a piece of property with the current zone, i.e., all lots would look the same. She added that with the proposed changes, we would have some variety in the setbacks, parking areas, etc.

Mr. Fraser described how the proposed amendment could allow developers to put up, for example, an office building close to the road with parking in the rear, etc.

Discussion followed re: connectors between parking lots, fencing, concern for lighting, signage, appreciation for the months that the Committee has worked on this project, etc.

Kenn Guimond, Committee Member, stated that the Route One South stretch had very restrictive zoning - the restrictions were absurd. He added that we have to relax the standards and not the quality; he feels the proposed amendment does this.

Ms. Cohen stated that under C-1, D-2, last sentence, the word "only" should be at the beginning; and, under C-2, D-3, the word "only" should be at the beginning.

These are as follows: for rates and services, change the daytime towing rates (7:00 A.M. to 7:00 P.M.) from \$35 to \$40 per tow; change the nighttime rates (7:00 P.M. to 7:00 A.M.) from \$50 to \$55 per tow; for storage fees, change from \$10 to \$15 for outdoor fees per day, and indoor storage to \$20 per day, both beginning after 24 hours from being impounded. A new section proposed is that if a vehicle operator wants to pick up his/her vehicle during the non-business hours (business hours being Monday through

Friday, 8:00 A.M. to 5:00 P.M.), a wrecker operator could charge an additional \$15 for picking up the vehicle. Another new section proposed is a minimum call-out, in the event that if a wrecker operator has been requested to come to a service, and for some reason that service is no longer needed, the operator can charge a minimum fee of \$10 for daytime service or \$15 for nighttime service. Regarding the section on vehicle inspection, proposed is eliminating the inspection by the Police Department.

Chairperson Beaulieu stated that the Traffic and Parking Committee has recommended that these changes be made.
