Councilor Mann noted that he received a call from Louisa Moore regarding the work done at the Mast Landing boat ramp area. The Conservation Trust had its meeting and came up with a four-part plan for the State to return and do corrective work at no cost to the Trust. The Trust's proposal does not include an area where people can drive down and launch their boats. Councilor Mann feels this is an important issue to the Town and since public money in the form of the DOT will be used, he feels it would be nice if the Town requests that the State hold a public hearing which would permit public input. Councilor DeGrandpre concurred that this would be a good idea since the area has suffered such a drastic change. Councilor Mann will bring this issue up under "Other Business" later.

Chair Soley and Jim Hatch explained that the Town will convey its interest to the Freeport Housing Trust which plans to develop two house lots. The remainder will be managed by the Freeport Conservation Commission which will provide an opportunity for a trail. Discussion followed.

#### OTHER BUSINESS:

1. Discussion on request to verify the status of Reed Road.

Susan Campbell of 38 Hunter Road explained that she purchased the property in 1994 thinking the Reed Road was a discontinued town road. She owns 1,500' frontage on the Reed Road. She is in attendance to listen to the discussion on this item. She answered questions for Councilors. Councilor Mann asked if she could provide written information from her title attorney that caused her to believe the road was discontinued.

Mitchell Rasor apologized for being late. He believes that the Town never voted to discontinue the Reed Road and is anxious to find out if another legal opinion was developed. He needs to know the status of the road so that he can know if he does business with the Town or with the abutters. The Town Manager has noted to Councilors that he does not believe the road was abandoned. Councilor Stevens pointed out that the information provided by Mr. Olmstead should be passed on to Mr. Rasor's attorney. Mr. Rasor agreed. Ms. Campbell asked for a copy of the information as well and was given a copy. Chair Soley noted that the Council is not prepared to deal with this issue tonight. Councilors concurred that once all the facts are presented on this issue to the Town Manager and they are given to the Council, the Council will decide if it needs a legal opinion before making a decision. Mr. Olmstead indicated that if the information is provided by the 19th, it will be discussed at the next Council Meeting on the 26th.

Discussion followed on the subdivision moratorium that is in place.

2. Update from the Burnett Road Bridge Committee.

Councilor Mann advised that six Councilors attended a meeting tonight and the Committee learned that in order to get any money for the bridge, it needs to meet federal standards. The State won't accept any design bid proposals unless the Town hires an approved Design Engineer. Discussion followed on whether to change the language that

will appear on the ballot in November. Chair Soley feels the language should remain as it is and let the voters vote on it. There was consensus from other Councilors to leave the language the way it is.

3. Meeting with the Freeport Housing Trust to discuss recent activities and future plans.

Betsy Ruff, President of the Freeport Housing Trust, advised that she has notified Councilors of the Trust's proposed purchase of Brookside, which is a 16-unit housing facility for low-income elders which opened in 1978. Renters pay 30% of their income. It is an expiring development and the developer will be free to put it back at market rate which would mean as much as \$600 or \$700. Chair Soley noted that he feels this is a valuable facility and if the numbers do not work out, he would be one vote to help with numbers.

4. Review proposal to provide non-emergency medical transports.

Mr. Olmstead explained how this might become advantageous to the community. Chief Fournier and Paul Conley explained the proposal and the budget required. They answered questions. A hospital and two nursing homes have indicated that they are very interested in working with Freeport.

Expanding this service will provide the department a way to pay its own expenses and he appreciates all the work done by the Town Manager and the two chiefs. Chair Soley echoed Councilor Mann's comments.

## ROLL CALL VOTE: (6 Ayes) (1 excused—Beaulieu).

Councilor Mann brought up the issue of asking the Town Manager to ask the Department of Transportation to schedule a public forum to discuss whatever they propose to do at the Mast Landing Boat Launch area. They did this when they proposed to replace the culverts.

Chair Soley does not see the need for this public meeting and it may delay the work being done. Councilor Stevens agreed that if a meeting could be scheduled quickly, fine but he would not like it to get in the way of actually doing the work. Councilor DeGrandpre agreed that a meeting would make sense.

MOVED AND SECONDED: To take up an item not on the printed agenda. (Soley & Arsenault) (6 Ayes) (1 Excused - Beaulieu).

MOVED AND SECONDED: That the Council instruct the Town Manager to communicate to the Department of Transportation of the State of the interests of the Town in the State redoing the work down there in a way that meets the interest of the public and to have it accomplished as soon as possible. 5. Recognition of receipt of a Hazard Mitigation Grant totaling \$183,743.

Mr. Olmstead explained that Jim Plummer applied for a FEMA Mitigation Grant and it was awarded to Freeport. He wanted to recognize Mr. Plummer's good work. The Town has received grant proceeds in the amount of three-quarters of a million dollars over the past year. By consensus the Council wants to recognize Mr. Plummer's hard work.

6. Discussion on electrical savings obtained through Maine Power Options.

Mr. Olmstead explained that the Town saved \$904 by joining Maine Power Options. This does not include the School Department. They enjoyed some savings as well, but Mr. Olmstead did not know what the savings were.

Over the past several months the Conservation Commission and the Housing Trust have worked together to formulate a plan for use of the tax-acquired property on Grant Road formerly owned by Harold Modes (Map 17/Lot 82). The resulting plan will provide maximum public benefit for both affordable housing and conservation uses. This plan was approved by the Board of Directors of the Freeport Housing Trust at their meeting of May 25, 2000, and by the Conservation Commission at their meeting of June 20, 2000. We therefore request that the Public Facilities Committee review our joint proposal and submit it to the Town Council for approval.

#### Joint Proposal for Grant Road Property.

1. FHT will accept the entire 10-acre parcel from the Town and will take responsibility for any legal costs required to clear the title.

2. FHT will develop two house lots from the parcel. These will be created to meet the minimum lot standard of 2.5 acres with 200 feet of frontage on Grant Road. FHT will use the lots to provide two affordable single-family homes for low-income Freeport residents. It is anticipated that at least one of these will be developed in cooperation with the Brunswick Chapter of Habitat for Humanity.

3. The remaining 5 acres, which is to be reserved for conservation purposes, will be deeded to the eventual long-term owner of the abutting conservation land, which is currently owned by the Nature Conservancy. It is assumed that the eventual owner will be either the Freeport Conservation Trust or the Town of Freeport. The shape of the 5-acre parcel will include the land behind the two house lots as well as a strip approximately 30 feet in width providing access from Grant Road to the back land.

Dear Dale:

I am writing to memorialize today's conversation. I understand a housing organization in Freeport has inquired whether, commencing for the next tax year, the Town Council will abate 50% of the taxes for some property it hopes to acquire shortly. There are problems with that request.

First, this would be a valuation abatement. Valuation abatements must be done by the Assessor, with an appeal possibility to the Board of Assessment Review. The Assessor takes his power directly from the state, once elected or appointed, and has both a statutory and constitutional obligation to assess all property equally according to just value. Stated differently, the Town Council does not have a role in valuation abatements. Second, the Town Council's only roles in the abatement area deal with errors or mistakes brought out by applications filed after one year, but within three years, of the date of commitment, or poverty abatements.

That is not to say that a municipality may not support housing programs, which can be done in a number of ways. I suggest that, rather than consider an abatement approach for the reasons discussed above, the municipality consider direct support. Direct support should be done in such a way that the public benefit is defined and protected.

I brought the Reed Road issue to the attention of the Conservation Commission members at our August meeting. While the Commission members have not had time to study the issue in detail, there are two concerns. Both involve access. First, the Commission is concerned that abandonment of Reed Road will decrease access options for forest management activities at Hedgehog Mountain, if the Commission should decide to undertake such activities in the future. Second, the Commission believes that the Reed Road provides a valuable trail corridor linking Hunter Road to the Hedgehog Mountain property. Given that trail access is an important element of Freeport's Open Space Plan and given that Hedgehog Mountain is a key natural and recreational area in Freeport, the Conservation Commission recommends caution in releasing any rights the Town may currently have in the Reed Road.

## CRITERIA FOR USE IN RECOMMENDING THE DISPOSITION OF PAPER STREETS\*

- 1. All public rights should be retained in any and all paper streets which provide access to rivers, bays, marshes and streams;
- 2. All public rights should be retained in any and all paper streets which provide access to publicly owned properties;
- 3. In determining what public rights should be recommended for retention in any and all paper streets, the Committee will consider the customary and historic use made of the property, the extent to which the town has maintained the street or property, and the extent to which the town has or has not enforced public or private rights in the property comprising the paper street;
- 4. In determining what public rights should be recommended for retention in any and all paper streets the Committee will seek to avoid creating "land-locked" parcels;
- 5. All public rights should be retained in any and all paper streets which may allow more cost effective delivery of municipal services such as sewer corridors, utilities, water, school bus transportation, etc.;
- 6. In any case in which an existing private structure is in place over a paper street, there is created a rebuttable presumption that the public has no remaining interest in that street, provided, however, that the presumption may be rebutted by a showing of an overriding public interest in retaining some public right in the street or by other relevant evidence;
- 7. (a) If no person, entity or the assigns of either has paid taxes on a continuous basis on the property comprising the paper street, there is created a rebuttable presumption that the town has full rights to the street and no private right remains therein;
- (b) Where a person, entity or the assigns of either has paid taxes on a continuous basis and the town has accepted those taxes, there is created a rebuttable presumption that the town has either not accepted the paper street, has retained less than a full interest in the street, or has vacated (or abandoned) the paper street;
- (c) Where the tax treatment of the property underlying the paper street lacks continuity, the Committee will consider the tax history of the property, as appropriate;
- 8. In determining what public rights should be recommended for retention in any and all paper streets the Committee will also consider any other issue or interest not previously identified or addressed, including but not limited to, current or future recreational uses, future development or conservation needs, the need for secondary access, public safety or emergency response needs, possible future public infrastructure needs or any issue currently unknown to, or unidentified by, the Committee that may be identified in the course of public hearings held on the recommended disposition of paper streets.
