CIRCLE OF EXCELLENCE PRESENTATION

Chairperson Beaulieu stated that it was her privilege to present the first Circle of Excellence Award. The idea of the award was conceived last spring; it became obvious that Preeport has been extremely fortunate to have several business leaders committed to the community and the people of Freeport for several decades. She added that the criteria for this award is that it would be awarded to an individual who may or may not be a Freeport resident, who has substantially contributed to the quality of the Town in job creation, employment retention and growth. The recipient will receive a plaque and a plaque will be hung in the Town Hall. She presented the award to Jonas B. Klein, CEO of Eastland Shoe Mfg. Co. She noted that in addition to employing over 700 employees and for over 30 years, has funded four scholarships annually to high school seniors.
