Outgoing Councilor Hindley was thanked for his dedication and hard work. Chair Beaulieu was also recognized for her contributions to the Town. A reception followed.

Chair Soley asked Councilors to think carefully about what they want to have as goals for the coming year and get them in writing to Kelly Profenno by 11/24. He also asked Councilors to indicate their interest in committees with "1" being used for their highest preference. This, too, needs to be submitted to Kelly Profenno by 11/24. If Councilors notice that there are Council meetings scheduled that they are very interested in but know in advance they will be unable to attend, they should notify Kelly Profenno. It may be possible to switch the topic to a different meeting. Mr. Olmstead noted that the 2/16 meeting is scheduled during school vacation week. It may need to be canceled if Councilors will not be in attendance.

Chair Soley explained that "jawing sessions" have been scheduled beginning 12/1 at 6 p.m. These are anticipated to be one-hour meetings where Councilors sit down without a specific agenda and talk about any issues they have on their mind and how things are going.

Chair Soley shared a list of his personal agenda items that he would like to do while on the Council this year. He suggested that Councilors compare their goals with his and then on 12/1 at 6 p.m., talk them through and come up with team goals.

Councilor Mann reported that he has walked the Town line in reference to the Pownal line. They found a number of problems as spelled out in the Surveyor's Report. The next step is to meet with Pownal representatives and discuss solutions and resolution to the problems such as replacing missing monuments and marking the Town line to meet State standards. He asked for authorization to go ahead and meet with Pownal representatives and then come back with recommendations needed for funding these improvements. It was the consensus of the Council that Councilor Mann should represent the Town of Freeport in connection with the Pownal issues and after learning all the issues, report back to the Town of Freeport.
