He mentioned the errors made on the ballot even though they were proofread carefully. Mr. Olmstead noted that discussions have been started on a joint bid effort with other areas to replace the old voting machines.

Councilor Beaulieu shared her thoughts regarding outgoing Councilor Campbell, noting his many accomplishments. He was presented with a plaque for his 10 years of very dedicated service. Mr. Olmstead noted that Town employees are in attendance tonight to honor Councilor Campbell. He recognized Councilor Campbell's accomplishments and presented him with a small gift. Pictures were taken. Councilors Stevens, Arsenault and Mann also had kind words for Councilor Campbell. They wished him well.

#### **OTHER BUSINESS:**

Discussion on filling the School Committee vacancy.

Mr. Olmstead explained that the Town Charter requires that when a vacancy occurs on the School Committee, the Town Council has the authority to appoint a new member to the School Committee until the next regular election takes place. Councilor Soley noted that the School Committee has advised him that they would like the Council to expedite the process and appoint a new member as soon as possible. Councilor Mann would like the position advertised town-wide in public service announcements on Channel 7 and in the newspapers. Councilor Beaulieu echoed what Councilor Mann said and would like to make an appointment at a meeting in December. Councilor Lowell advised that Patrick Enking has shown an interest in serving on the School Committee and has met with the School Committee several times. She wanted the record to reflect this.

Councilor Beaulieu suggested that the applications be requested by November 30 and that this item be placed on the December 5 agenda. Councilors concurred that the applications should be requested by the 28<sup>th</sup> of November and the Appointment Committee could meet at 5 p.m. on the 29<sup>th</sup> for interviews. Mr. Enking will participate in the first interview. Councilor Beaulieu clarified that the existing Appointment Committee will be involved. She requested that Councilor Lowell should attend that meeting as an observer.

ITEM #204-00

To consider action relative to an Executive Session to discuss the acquisition of property.

MOVED AND SECONDED: That the Council enter into Executive Session to discuss the 92 acres owned by Scott and Margaret Keith on the Pownal Road. (Councilors Soley & Beaulieu) (7Ayes)

MOVED AND SECONDED: That the Council reconvene. (Councilors Soley & Beaulieu) (7 Ayes)

MOVED AND SECONDED: That the Town Council accept the contract that has already been signed by Margaret and Scott Keith and West Freeport Partners, Inc. and that we authorize the

Town Manager to sign this contract tonight on behalf of the Town of Freeport. We further move that we pay for the \$220,000 purchase price for this property by taking \$50,000 out of the Hedgehog Mountain Fund and by taking \$100,000 out of the Land Bank Fund and that we authorize the Freeport Conservation Commission to raise the remaining funds by grants or donations as they deem appropriate. In addition, we move that we authorize the Freeport Conservation Commission to move forward with this transaction and do everything that is diligent to move forward and report back to the Town Council on December 19 to give feedback on the due diligence. We finally move that the Council authorize up to \$7,000 from the fiscal year 2001 Miscellaeneous and Contingency Account to pay for the cost of the due diligence that the committee feels appropriate. (Councilors Soley & Beaulieu)

Councilor Mann noted why he will be voting in favor of this. Councilor Beaulieu wanted the record to reflect that if we get to 2002 and we haven't raised the \$70,000 from outside sources, whatever hasn't been raised will be taken from the Land Trust. The record should reflect that the \$220,000 will be paid over time with 0% interest.
