PROPOSED CONSERVATION COMMISSION CRDINANCE.

Section 1. ESTABLISHMENT

1.1 The Freeport Conservation Commission is hereby created and established pursuant to the provisions of Subchapter II of Chapter 229 of Title 30 of the Maine Revised Statutes.

Section 2. ORGANIZATION

- 2.1 The Commission shall consist of five members appointed by the Town Council to hold office initially for 1, 2, 3, 4 and 5 years, respectively, and after the first year the Town Council shall appoint annually a Commissioner for a five-year term to fill the vacancy created by the member whose term expires.
- 2.2 Members shall be residents of the Town of Freeport and shall serve without compensation.
- 2.4 The Commission shall annually elect a chairman, a vice-chairman and a secretary from its membership and may create and fill such other offices as it may

determine. Officers shall serve one-year terms and shall be eligible for re-election.

- 2.5 When there exists a permanent vacancy, the Town Council shall, within sixty days of its occurrence, appoint a person to serve for the unexpired term.
- 2.6 Members may be removed by the Town Council for cause, after notice and hearing.

Section 3. DUTIES

The Conservation Commission:

- 3.1 May, as delegated to it by the Town Council from time to time, have the care and superintendance of public parks as designated by the Town Council and, subject to the approval of the Town Council, direct the expenditure of all moneys appropriated for the improvement of same.
- 3.2 Shall conduct research, in conjunction with the Planning Board, into local land areas.
- 3.3 Shall seek to coordinate the activities of conservation bodies organized for similar purposes.
- 3.4 May advertise, prepare, print and distribute books, maps, charts, plans and pamphlets which in its judg-

ment it deems necessary utilizing such funds as may be donated to the Town of Freeport or appropriated by the Town Council for such purposes.

- publicly or privately owned, within the Town of Freeport, including marsh lands, swamps and other wetlands for the purpose of obtaining information pertinent to proper utilization, protection, development or use of such open areas.
- or any agency of the State of Maine, a program for better utilization, protection, development or use of such open areas, which recommendations may include the acquisition of conservation easements.
- 3.7 May, after approval of the Town Council, acquire land in the name of the Town of Freeport for any conservation purpose.
- 3.8 May, after approval of the Town Council, receive gifts in the name of the Town of Freeport for any conservation purpose and shall administer same for such purposes, subject to the terms of the gift.

- 3.9 Shall keep records of its meetings and activities and shall make an annual report to the Town Council to be published as part of the annual report of the Town of Freeport.
- 3.10 Shall perform such other duties as may be delegated to it from time to time by the Town Council.

Section 4. SAVINGS CLAUSE.

4.1 The invalidity of any provision of this Ordinance shall not affect the validity of any other provision.

Section 5. EFFECTIVE DATE

- 5.1 This Ordinance shall take effect thirty (30) days after its enactment.

PROPOSED CONCEALED WEAPON ORDINANCE

Section 1. LICENSE REQUIRED

1.1 No person shall wear under his clothes or conceal about his person within the Town of Freeport any firearm or other dangerous or deadly weapon unless first licensed to do so in accordance with the provisions of this Ordinance and the Laws of the State of Maine.

Section 2. QUALIFICATIONS

therefor and after such investigation as the Chief of Police may deem necessary, issue a license to carry such weapon to persons qualified in accordance with the provisions of this Ordinance.

2.2 Applicants for a license hereunder must be legal residents of the Town of Freeport, of good moral character, at least eighteen (18) years of age and shall not have been convicted of, or be under complaint or indictment for, assault, assault and battery or a felony; be a user of or be addicted to marijuana or any other depressant, stimulant or

narcotic or other dangerous drug; and also shall not have been judged by a court as a mental defective or have been committed to, or voluntarily been a patient at, a mental institution.

2.3 Applicants for a license hereunder shall further certify in writing to the Chief of Police, together with the reasons therefor, that a license to carry a concealed weapon is required for the personal safety and protection of the licensee or required in connection with the employment of the licensee, and if the latter, the application and certificate shall be so endorsed by the employer.

Section 3. LICENSE TERM

3.1 All licenses shall be valid until the end of the calendar year in which issued unless sooner revoked by the Chief of Police or Town Council. Any license

issued in connection with employment shall cease to be valid when the employee leaves the employment of the employer who endorsed the application.

Section 4. RECORDS

- 4.1 The Chief of Police shall make a permanent record of all applications and licenses issued in a suitable file kept for that purpose in the Police Department.
- 4.2 Such record shall include the date of issuance, the name, age, sex and street address of the licensee, together with a complete description of the weapon, and in the case of firearms, the caliber, make, model and serial or other identification number.

Section 5. EXEMPTION

5.1 This Ordinance shall not apply to duly appointed and qualified police officers, constables or other officers charged with the enforcement of law.

Section 6. PENALTY

6.1 Whoever violates any of the provisions of this Ordinance shall, upon conviction therefor, be punished by a fine of mot more than \$100.00.

Section 7. SAVINGS CLAUSE

7.1 The invalidity of any provision of this Ordinance shall not affect the validity of any other provision.

Section 8. EFFECTIVE DATE

- 8.1 This Ordinance shall take effect thirty (30) days after its enactment.

PROPOSED CONSTABLE'S COMMISSION ORDINANCE

Section 1. APPOINTMENT

Town Council may appoint for not more than one year, remove, control and fix the compensation of so many constables of the Town of Freeport as may, in the opinion of the Town Council, be necessary or required to serve the needs of the public safety or welfare of the Town of Freeport.

Section 2. QUALIFICATIONS

2.1 Constables shall be residents and qualified voters of the Town of Freeport, of good moral character, and no constable commission shall be granted to any person who has been convicted in any State of the United States of a felony.

Section 3. APPLICATION

- 3.1 All applicants for the position of constable shall submit to the Chief of Police, in such form as may be prepared and approved by the Chief of Police, all pertinent information relative to the applicant's qualifications for the position of Constable.
- 3.2 All applicants shall be fingerprinted by the Freeport Police Department, and the Chief of Police shall submit the fingerprints of each applicant to the appropriate State and Federal agencies for classification and criminal record.
- 3.3 In addition to the foregoing, the Chief of Police shall conduct, or cause to be conducted, such investigation regarding the applicant's qualifications as he may deem appropriate.

3.4 All information relating to each applicant shall be presented to the Town Council, together with a recommendation of the Chief of Police, and the Chief of Police shall present himself to the Town Council to answer any questions regarding each applicant.

Section 4. OATH OF OFFICE

4.1 Upon approval and appointment, every constable shall forthwith qualify for the office by taking the required oath of office before the Town Clerk, which oath shall be subscribed by the Town Clerk and filed and preserved in the Municipal Offices.

Section 5. REMOVAL

5.1 The Town Council may remove any constable from office for cause, after notice and hearing.

Section 6. APPLICABILITY

6.1 This Ordinance shall not apply to Police Officers and Reserve Officers of the Freeport Police Department.

Section 7. SAVINGS CLAUSE

7.1 The invalidity of any provision of this Ordinance shall not affect the validity of any other provision.

Section 8. EFFECTIVE DATE

- 8.1 This Ordinance shall take effect thirty (30) days after its enactment.
