ITEM NO. 182

Be It Ordered - That the Town Manager be authorized to sign a quit claim deed to Michael Cavanaugh and and Erma Cavanaugh on an expired tax lien on land and buildings in Freeport described as Tax Map 19 Lot 76 and registered at the Registry of Deeds, book 2538, page 264 for collection of taxes committed June 1959. (Messrs. Small & Bonney) (7 Yes) (0 No).

Moved and Seconded - To further revise the motion made by Mr. Bonney and seconded by Mr. Small on July 3, 1973 regarding the Conservation Commission Ordinance as follows:

- 2.1 . . . The Town Council may also appoint, for terms of 1 year, up to 5 associate members of the Conservation Commission which associate members may assist in the work of the Conservation Commission and participate in its discussions but shall hold no office and have no vote.
- 2.2 Members and Associate Members shall be residents of the Town of Freeport and shall serve without compensation.
- 2.6 Members and Associate Members may be removed by the Town Council for cause, after notice and hearing.

3.6 May recommend to the Town Council or Planning
Board or any agency of the State of Maine, a
program for better utilization, protection,
development or use of such open areas.

TTEM NO. 167 "The Town of Freeport hereby ordains" the Conservation Commission Ordinance introduced at Town Council Meeting #21-73 with Sections 2.1 and 2.3 revised as follows:

- 2.1 The Commission shall consist of five members appointed by the Town Council to hold office initially 2 members for 3 years, 2 members for 2 years and 1 member for 1 year, respectively, and after the first year the Town Council shall appoint annually a Commissioner for a three-year term to fill the vacancy created by the member whose term expires.
- 2.3 Neither a municipal officer nor a member of the Freeport Planning Board may be a member of the Conservation Commission.

 (Messrs. Bonney & Small) (7 Yes) (0 No).

Moved and Seconded - To revise the motion made by Mr. Bonney and seconded by Mr. Small on July 3, 1973 regarding the Concealed Weapon Ordinance as follows:

- 1.1 No person except duly appointed and qualified Police Officers of the Town of Freeport shall wear under his clothes or conceal about his person within the Town of Freeport any firearm or dangerous or deadly weapon unless first licensed to do so in accordance with the provisions of this Ordinance and the Laws of the State of Maine.
- 2.1 The Chief of Police may, upon written application therefor and after such investigation as the Chief of Police may deem necessary, issue subject to the confirmation of the Town Council a license to carry such weapon to persons qualified in accordance with the provisions of this Ordinance.
- 5. EXEMPTION (Delete and progressively renumber the succeeding paragraphs).

TTEM NO. 168 "The Town of Freeport hereby ordains" the Concealed Weapon Ordinance proposed at Meeting #21-73.

(Messrs. Bonney & Small) (7 Yes) (0 No).

Moved and Seconded - To revise the motion made by Mr. Bonney and seconded by Mr. Leighton on July 3, 1973 regarding the Constable's Commission Ordinance as follows:

- 1.1 In accordance with the provisions of this Ordinance, the Town Manager may appoint, subject to confirmation by the Town Council, for not more than one year, suspend, control and fix the compensation of so many constables of the Town of Freeport as may, in the opinion of the Town Manager, be necessary or required to serve the needs of the public safety or welfare of the Town of Freeport.
- 2.1 Constables shall be of good moral character, and no constable commission shall be granted to any person who has been convicted in any State of the United States of a felony.
- 3.1 All applicants for the position of constable shall submit to the Town Manager in such form as may be prepared and approved by the Town Manager, all pertinent information relative to the applicant's qualifications for the position of Constable.
- 3.4 All information relating to each applicant shall be presented to the Town Manager, together with a recommendation of the Chief of Police, and the Town Manager shall present himself to the Town Council to answer any questions regarding each applicant.

Section 4 OATH OF OFFICE, BOND

- 4.1 Upon approval and appointment, every constable shall forthwith qualify for the office by presenting to the Town Treasurer a surety bond in an amount approved by the Town Manager and by taking the required oath of office before the Town Clerk, which oath shall be subscribed by the Town Clerk and filed and preserved in the Municipal Offices.
- 6. APPLICABILITY (Delete and progressively renumber the succeeding paragraphs).
