ITEM NO. 202 Be It Ordered - That Paul Wentworth, David Whitten, Sally Rand, Maxine Palmer and Paul Dunn be appointed as members of the Conservation Commission.

Be It Further Ordered - That Paul Wentworth and David Whitten serve until September 1, 1976; that Sally Rand and Maxine Palmer serve until September 1, 1975; and that Paul Dunn serve until September 1, 1974.

Be It Further Ordered - That James Sellinger, Suzanne Harding, Janice Fogg, Martha Gottlieb and David Graham be appointed as Associate Members of the Conservation Commission to serve one year terms.

Be It Further Ordered - That the Members and Associate Members of the Conservation Commission qualify by swearing an oath of office before the Town Clerk of Freeport no later than September 21, 1973.

Be It Further Ordered - That the Conservation Commission meet to organize by electing a Chairman and the required officers no later than September 28, 1973.
