RE: Freeport Charter

Dear Bruce:

With reference to your recent inquiry concerning the term "interference" as it appears in Section 2.06 (c) of the Freeport Town Charter, I would offer the following.

I note that the term "interference" appears only in the heading of that particular section of the Charter. It is my belief that the general law states that such headings are not a part of the legislative documents and have no force of law except, in certain limited cases, to offer some legislative history or explanation of the intent of the draftsmen.

In my review of the actual text of the section, I do not note any apparent conflict in language or any inconsistencies. My impression is that the text should be read literally and it is my understanding that such a section is inserted to reinforce the "chain of command" concept inherent in this type of Town Manager form of government. In other words, my understanding of this section is that it was intended to preclude council members from giving direct orders concerning municipal business to Town Manager subordinates and to require that any such directives are limited to the Town Manager who, in turn, bears the ultimate responsibility of implementing the directives.

I hope that the foregoing information is of some assistance to you and the members of the Council, and should you have any further questions, please feel free to give me a call.
