ITEM NO. 262

Be It Ordered - That a permit to operate in a Wetlands Control area as requested on January 25, 1974 by the Freeport Sewer District for installation of sewer mains and treatment plant outfall be granted approval subject to approval by the State of Maine Wetlands Control Board.

Be It Further Ordered - That upon receipt of Wetlands Control Board approval, the Town Manager be authorized to issue the following permit:

After review of the Wetlands Permit Application, supporting documentation and comments received at the public hearing held by the Town Council on February 19, 1974, pursuant to Title 12, S4701, the Freeport Town Council concludes that a Wetlands Permit be granted to the Trustees of the Freeport Sewer District with the following conditions:

- 1. Construction shall not begin in any wetlands area located between the terminus of Dixon Avenue in South Freeport and the Weston Point, so called, located at the eastern terminus of the Cushing Briggs Road until all conditions stated herein are satisfied.
- 2. The applicant shall provide for Council review of all final construction plans for dredging and all final design plans for any equipment that will be permanently located in any wetlands area as indicated above.
- 3. Such final design plans shall have received prior approval from applicable State and Federal agencies. Copies of each approval shall be given to the Town Manager as these approvals are granted.

- 4. The applicant shall provide information relative to any proposed Harbor batch sampling/testing program that the Trustees plan in order to maintain a minimum SB-2 rating.
- 5. The applicant shall appear before the Town Council at a public information meeting prior to bidding and construction so as to inform the citizens of the Town of Freeport of:
- (a) Final design and specification of sewage disposal equipment and materials that will affect areas cited in Section 2 of this permit.
- (b) Final specifications for treatment of effluent to be discharged into the Harbor.
- (c) Final location of outfall pipe.
- (d) Final location of pump stations, force mains and interceptor systems in areas affected by this permit.
