

Statement read by Council Chairman Curtis:

Criminal charges made against present or former Town employees have been referred to the Attorney Ceneral's Office and District Attorney's Office for investigation. With regard to other charges made by Mr. Campbell, his attorney was given a procedure to fully air these charges in a way fair to all. This procedure was not responded to or objected to in a timely manner by Mr. Campbell or his attorney. Specifically, Mr. Campbell, through his attorney, has failed to provide the Council with a sworn set of allegations which has twice been requested by the Council as a minimum necessary to begin procodures which could result in a serious damages to the reputation and livlihood of those charged.

Because of Mr. Campbell's failure to respond or object to the proposed procedure within the time specified and because of the length of time this matter has been pending, the Council feels that its consideration of this matter is at an end. Should facts come to the Council's attention as a result of the investigation of the Attorney General's Office or District Attorney's Office which warrants new attention, of course, further action may be taken.
