

COUNCIL MEETING #4-82 FEBRUARY 16, 1982

Moved and Seconded - That the Council hear a report by the Chairman of the Oridnance Committee on the Proposed Amendment to the Town Charter.

Chairman Swan: In reference to Paul Frinsko's letter, as Mr. Frinsko has indicated, there are complex issues of law. The Ordinance Committee has met and what we recommend is that there be a workshop scheduled for March 16 with the Council, School Committee and Mr. Frinsko or his representative to further discuss this amendment before we schedule a public hearing.

Council Chairman Swan reported on the Fiscal Analysis Task Force: we have met numerous times; we have finalized both the municipal and education 5 year projections of expenses and revenues; the final draft of our projections are to be reviewed tomorrow. The next step is to try to finalize recommendations to go along with these 5 year projections. The Committee wants to review these projections on a year to year basis. Some formal report will be presented to the Council by the beginning of April.

Chairman Leo Valliere reported on the School Committee Task Force: we have had several meetings; we've had excellent cooperation from the School and Mr. Cartmill regarding our plans; we have also met with the hot lunch program coordinator, met with Marshall Bowden on transportation and maintenance on the school. We have a meeting tomorrow night with Mr. Graham. A final report will be forthcoming around the first of April.

Chairman David Coffin reported on the Public Works Task Force: we have met numerous times; we've had to work around many storms; we are gaining very well; we have covered pretty well the entire department. Our final report will be forthcoming in April.

Chairman William Lunt reported on the General Government Task Force: we've had a meeting once a week; we've gone through the various departments; we have had tremendous cooperation from everyone. We will be meeting with the Town Manager and areas of his concerns; we do not have any recommendations at this time.

Chairman Hollis Willett reported on the Library Task Force: I am in the process of setting up a meeting; no recommendations at this time.

Chairwoman Vaughndella Curtis reported on the Police Department Task Force: we have met every other week; we have documented equipment; we have gone through last year's budget. We will be ready by April 1 with a report. We will be meeting with the Harbormaster and Clam Warden in the near future.

Chairman Edward Hindley reported on the Fire and Rescue Task Force: we have had several meetings; we have discussed past, present and future; we will have a final report by April 1.

Town Manager Benway stated that an Election Warden has to be appointed. John Swan kindly volunteered his time until 5:00 P.M. and Edward Hindley would then take over.
