

Richard Golden, Chairman of the Cable TV Regulatory Board, spoke to the Council regarding the problems the cable tv co. has had with the utilities companies. Work has finally started on Wardtown Road by the utility company. Approximately 8 weeks from the first hookup will be sufficient time for stringing cable provided it doesn't rain. The cable tv co. has switched ownership/partnership - it's a way of obtaining capital which also benefits 5 other communities besides Freeport that they are involved in. However, the person who signed originally with Freeport is also the same person in the change of ownership. Council Chairman Coffin stated the Council is not ready to answer as they are awaiting a response from the town attorney. The cable tv company is proposing that the Council formalize something in writing. Utilities should be completed, the latest, the first week in August.

Interim Town Manager Palmer spoke regarding a problem with a catch basin on Oak Street in front of Ray Tozier's house. The only way to resolve the problem is to get a back hoe and dig it up: Council agrees.
