Council Chairman Coffin stated that it's feasible to support the wharf on the easterly side of the island; Council is to work up a formal plan on what they are willing to do.

Mr. Larry Welscher spoke to the Council regarding constructing a new post office for South Freeport; the approval he would need plus discussed problems occurring by requiring a zoning change to the area. Some members of the Planning Board, Mr. Thompson and Mr. Carew also spoke on behalf of the Planning Board. Chairman Coffin related that this matter will be taken up during workshop next Tuesday.

Former tenants from Fortin's Trailer Park spoke to the Council regarding some problems they were encountering. Material was passed out to the Council; Chairman Coffin stated this matter would be discussed at their next workshop scheduled for next Tuesday night.

Councilor Davenport brought out the matter with Libby/Cox property; Mr. Coffin informed him the Council was awaiting legal word from the town attorney before they could answer this problem.
