

The Town of Freeport Hereby Ordains-That the Proposed Amendment to the Freeport Zoning Ordinance to Create a New Rural-Commercial Zone to Provide for Commercial Sales and Service, as submitted to Public Hearing on November 1, 1982, be adopted.

The Town of Freeport Hereby Further Ordains - That the Freeport Zoning Map, dated October 1975 and revised January 1982, be further amended to provide that: The parcels of land designated on the Town of Freeport Property Maps, dated April 1, 1982. as Map 21 - Lots 42E, 43, 45B, Easterly Half of Lot 96; Map 22 -Lots 74, 35, 34, 77, 76, 75; Map 21-Lots 98, 97B, 42B, and all lots within the boundaries of the lots so-named be rezoned from Rural Residential I (RR-I) to Rural-Commercial, be adopted. (Councilors Swan & Valliere) (6 Ayes) (1 Nay, Councilor Davenport) Attorney James Palmer representing Mr. Arvid Magno spoke on behalf of his client and presented the Councilors with an offer to allow Mr. Magno another 17 days to remove the personal property from the property on Oak Street; Joseph Downey, Assessor, brought up the fact that the property is in fact in Mrs. Magno's name and was Council aware; Attorney Palmer was prepared to offer a check made out to the Town of Freeport in the amount of \$3,550.00 to pay the back taxes but did stress he was not prepared to accept any conditions the Town would place on this acceptance because he was only the "stand in attorney" for Mr. Magno; after discussion among the Councilors, Council Chairman Coffin stated the Council would not accept any monies and any extended time requested by Mr. Magno was denied.
