Be It Ordered: That the following referendum question shall be submitted to the voters of the Town of Freeport at the general election to be held November 7, 1989. (Councilors Goddard & Campbell) (7 Ayes) (0 Nays)

Referendum Question No. 1:

Shall a school construction project having a total estimated project cost of \$5,570,000 and consisting of the design, construction and equipping of a new Upper Elementary School to be located on land of John W. L. White and Alva Holbrook between Bow Street and Lower Mast Landing Road in Freeport, be approved; and shall the Treasurer and Chairman of the Town Council be authorized to issue bonds or notes of the Town to fund this project in a total principal amount not to exceed \$5,570,000?"

Explanation and Recommendation: This proposed school construction project has been approved by the Freeport School Committee and has received concept approval from the State Board of Education. The entire additional operating costs of the new project during its first 2 years shall be borne by revenues raised by the Town of Freeport. The estimated amount of additional operating costs during each of the first 2 years is \$32,000.00. The Town of Freeport shall be responsible for the local share of debt service allocation to be calculated in accordance with State Law.

Referendum Question No. 2:

"Shall a school construction project having a total estimated project cost of \$5,570,000 and consisting of the design, construction and equipping of a new Upper Elementary School to be located on land between Bow Street and Lower Mast Landing Road in Freeport, as shown on the Assessor's Maps as Map 14, Lot 8 and Map 20, Lot 75A, be approved; and shall the Treasurer and Chairman of the Town Council be authorized to issue bonds or notes of the Town to fund this project in a total principal amount not to exceed \$5,570,000?"

Explanation and Recommendation: This proposed school construction project has been approved by the Freeport School Committee and has received concept approval from the State Board of Education. The entire additional operating costs of this new project during its first 2 years shall be borne by revenues raised by the Town of Freeport. The estimated amount of additional operating costs during each of the first 2 years is \$32,000. The Town of Freeport shall be responsible for the local share of debt service allocation to be calculated in accordance with State If this new school project is not given final approval by the State Board of Education for state funding, the School Committee does not intend to proceed with the project. The Town Council and the School Committee recommend approval of this question.

Explanation: The purchase price of this project is Four Hundred Thousand Dollars (\$400,000). Fifty Thousand Dollars (\$50,000) has been allocated from the Municipal Land Bank and Sixty One Thousand (\$61,000) has been raised by private donations. The balance will be funded by this bond issue.

- 2). A presentation on Hazardous Material Force by Darrel Fournier was given. The consensus of the Council was to support the concept but not support the funding mechanism. Looking into other methods of funding was suggested.

 - 6). A letter from Mike Charek (Library Renovation Project) was brought to the attention of the Council. Several Change Orders are needed for this project and the Town Manager was given the authority to sign for these change orders.
