Supt. of Schools, Robert Lyman, explained that in order for the State to pay \$5,548,000 toward the New School, leaving Freeport's share of \$22,000, there must be a positive vote to build the school by the voters.

Steve Black, architect, gave a detailed description of the buildings - stating it covers 42,600 square feet, will house Grades 3 thru 5, will hold 360 students, faces southerly, will have a defined entrance separating school buses loading and unloading from passenger vehicles, will have 3 levels with 3 defined school areas.

Mr. Lyman further explained that the owner of the property is holding one small parcel which could be used for future expansion on the other side of the recreation field. Dept. of Transportation will consider cost-sharing for improving roads for student safety. The Town, at this point, has expanded \$70,000 toward the New School - if the voters reject the School Project, the Town of Freeport will not be liable to go ahead with the construction, however, the \$70,000 will not be returned.

Other Business:

A presentation on a New County-Wide Jail for Cumberland County was made by Edward Bonney, Cumberland County Commissioner, and Wade Sanders, Administrator of the present jail: a new jail is needed because 1) the present one is too small, 2) the present one is not safe and does not create a secure environment for inmates and workers, and 3) is very inefficient and costful. The present jail was built to accommodate 100 prisoners - it actually houses 238 immates. The jail serves 26 communities as a holding facility - the jail is not in compliance with State or Federal standards, however, the Department of Corrections has given variances to keep the facility open predicated on the County resolving the problem - 72% of all prisoners are County residents -44% live in Portland. The future jail will house 340 prisoners, should be adequate through the year 2,010, and will house juveniles in a separate facility. It will need 20% more staff and 130% more beds. Several sites were looked at which were close to the courthouses - the new facility is scheduled in back of the Old Union Station - has approximately 10 acres a second parcel considered was on Outer Congress Street behind the Regional Waste Systems. It is estimated to cost 11¢ per \$1,000 of valuation for each community in Cumberland County - monies are based on a 30-year cost analyses maintaining the present facility would cost over \$345,000,000 - to renovate would cost over \$314,000,000 - new construction would cost over \$256,000,000. If voters reject the new jail - they would only be able to house 100 immates in the present building and other prisoners would have to be housed elsewhere at a considerate cost. The Administrator, Mr. Sanders, pointed out they are going to institute a program whereby the linmate would work and the monies earned would go toward defraying the inmate's upkeep.

Other Business Continued -

Councilor Grady reported on the Traffic and Parking Committee: the Committee
is looking at the T.Y.Lin Study on Parking, signage for the merchants, some
recommendations from the Police Chief, and library parking problems.

Bill Easton, the Consultant, explained "time of day parking" which limits parking to a certain portion of the day - he stated that might work in Town, but, strongly recommended that Freeport not use it.

Councilor Goddard was excused at 10:29 P.M.
