Public Hearing: may 1,1 PROPOSED AMENDMENTS TO THE RULES FOR WINSLOW PARK

4/10/90

(Chapter 34)

The Manager of the Park is responsible to the Town Manager.

- 2. The Park will open Memorial Weekend through September 30.
- 3. The Park will be open from 8:00 am to 10:00 pm in July and August. From Memorial Weekend thru June and all of September it will be open 9 am to 9 pm. The gate closes at 10:30 pm. The Park including beach and picnic areas will close for Day Use and Visitors one half hour after sunset.
- 4. Pets are allowed in the Park under restraint and shall not be left unattended. Pets are to be on a leash that does not exceed 6 ' in length and shall be in the control of the handler. Only the one per campsite. (No pets on the beach). Pet owners are required to clean up after their pets <u>immediately</u>.
- 5. The discharge of firearms or other weapons and hunting is prohibited. Fireworks are also prohibited.
- 6. All vehicles shall conform to posted regulations as to speed and parking. Vehicle speed in the park is not to exceed 5 miles per mile, and vehicles will park in designated areas only. Automobiles motorcycles, bicycles and vehicles are allowed as transportation to and from the park, but will be restricted if used unnecessarily or are a nuisance because of noise. No overnight parking shall be allowed from the Westerly property line for Winslow Park to the <u>Main Gate.</u>
- Open fires where permitted shall be confined to fireplaces furnished for that purpose and shall be kept to a reasonable size. Fires will be restricted to areas so designated. No fires shall be <u>left</u> unattended.
- 8. The removal, molesting, injury or damage to anything natural, physical or historical within the area is strictly prohibited and may result in eviction with forfeiture of fees paid. No digging, trenching, or metal detectors allowed.
- 9. Disorderly conduct, including being under the influence of controlled substances, indecent acts, or the use of coarse language, may result in eviction with forfeiture of fees paid.
- Refuse must be placed in containers provided or packed out.
- 11. Park Personel are not permitted to accept gratuities.
- 12. Ball playing, frisbee throwing, and similar activities shall not interfere with the enjoyment and safety of other park users.
- 13. Camping groups are wrood to dive advance notice and reserve space ds decressity with the patk supplyisor. Groups shall be defined as organizations that are social, terigious, service, showethal political, charitable, commercial or corpotate, prins large family gatherings that do not law into any other carpygoty.

- 14. 13. Group use shall be confined to those areas so designated or assigned by the Park Supertisor Manager.
- 15. 14. Group <u>reserved area</u> day use should be reserved in advance (after Feb.1) by contacting the Park Supervisor Manager and by paying a non-refundable deposit. Groups that are juvenile in nature shall have one adult supervisor per 6 children.
- 16. 15. Campers must register in person before setting up camp on a site.
- 11. 16. Vahily dahosites was not be reserved. Organized groups, see fulf # 13. Camping Reservation System:
 - a. Reservations will be accepted postmarked no earlier than Feb. 1 and must be made 14 days prior to the first night requested. Payment for time reserved plus \$ 1 per night service charge must be included with reservation form. In the event of cancellation, campers must notify the park at least 7 days in advance and a 3 day fee will be forfeited.
 - b. Time reserved will be limited to a minimum of 3 days and a maximum of 14 consecutive days.
 - c. A limited number of campsites available for seasonal use.

 Reservations will be accepted postmarked no earlier than Feb. 1

 and must be made by March 1st. Payment of a deposit must be be
 included with the reservation form. One half of the remaining
 fee is due on April 1st and the remainder on registration.
 - d. Sites 1 23 cannot be reserved.
- 18. 17. The number of camping parties admitted to the area will be limited to the number of campsites available (normal authorized campsites should not exceed 100 lots). Overloads limited to 10 sites and must have prior approval of the park Superintendent Manager.
- 18. 18. Check out time is 1:00 p.m.
- 20. 19. Vacancies will be filled <u>either by the Winslow Park Campsite</u>
 <u>Reservation System</u> or on a first come first served basis.
- 21. 20. Camping shall be limited to a period of 14 consecutive nights at one lot site, excepting that the Park ships introduct Manager may rent lot sites for up to thirty consecutive days, when such sites are available, during the month of June with completion of all or a portion of the 30 day period ending on July 1, and during the month of September until the park closes, and excepting that the Park superintendent Manager may authorize the renewal of camping on the same lot for up to an additional 14 consecutive days during the months of July and August if no other request is received for said lot in the 24 hours immediately following a request to renew a such camping. Fourteen nights shall be a limit on sites 1 to 23 during July and August.

- 22. 21. Campsite occupancy will be limited to one camping party.
- 23. 22. A camping party shall be defined as: (\$44 PAIA #15 for
 - a. Family: One or two parents and their minor children using an RV and/or number of tents necessary and appropriate to accommodate family and lot size.
 - b. Non- family: Maximum 6 adults per campsite. Fee covers 2 adults and one shelter. Additional fee will be charged per each additional adult and per additional shelter. Maximum of 2 shelters per site if appropriate to lot size.
- 24. Jahrsite visitots vill be allowed :

 a. Landsite visitots vill be allowed fied of charge up to 1/2

 point to transact personal koeiness with campers. For visits of

 more than 1/2 hold, pay bee fee vill be charged. Coentight

 ghests must register and pay a lee.

 b. Check out rine is 1 p.m.
- 23. Daytime campsite guests must register and pay a day use fee.

 Overnight campsite guests must register and pay a fee.
- 24. \(\notin \). Generators may be used only from 8 9 a.m., lla.m. lp.m., and 5 -7 p.m.
- 25. a. Clotheslines will be confined to the campsites. No rope, twine or wire will be attached to trees or shrubs.
- 26. \(\noting \). Quiet hours are from 11 p.m. to 7 a.m.
- 25. 27. No more than 2 automobiles will be allowed in any one campsite in addition to the registered recreational vehicle.
- 26. 28. Automobiles, motorcycles, bicycles and vehicles are allowed as transportation to and from the park, but will be restricted if used unnecessarily or are a nuisance because of noise. ATV's are not permitted.
- 27. 29. Group campsites must be reserved in advance by contacting the Park Manager or his designee.
- 28. 30. No overnight parking shall be allowed from the Westerly property line for Winslow Park to the Main Gate.
- 29. 31. Bathing will be restricted to the area so designated.
- 30. 32. Boating and water skiing must be outside the designated swimming areas.
- 31. 33. The use of floating devices are permitted providing they are U.S.C.G. approved. Face masks or snorkels are prohibited, except that the Coast Guard approved life jackets may be used at the discretion of the Park Manager. S.C.U.B.A. and skin divers must register at the gate house with a current C card from a nationally recognized organization, the location of the planned dive, and expected time of return.

- 32. 34. Pets are not allowed on the beach.
- 33. 35. Fires or grills are not allowed on the beach.
- 34. 36. The use of soaps and detergents are prohibited on the beach.
- 35. 37. There are no lifeguards at the beach area. Swimming is at your own risk and is restricted to the sand beach.
- 36. The Keach and piopic areas close one half hour after sunset.
- 37. 38. The use of these areas in the Park which shall be limited to the purposes for which they are being preserved and to activities determined by the Park Manager to be compatible with the those purposes intended use of the lacility the Park Manager.

 The following are not allowed in the beach area from the boat launch ramp to the next point of land, north and east: Boating, water skiing, clamming and worming.
- 38. 39. A donation fee towards future ramp repairs is required from boat launch ramp users.
- 39. 40. A campsite for park personell will be supplied at no cost only if that person is assigned to night time duty.
- 40. 41. Reservations will be accepted postmarked no earlier than Nov.l for Harb Cottage. Persons who rent Harb Cottage are responsible for seeing that their guests comply with the rules of the park.
- 42. The scenic trail shall be maintained as a park commons to be maintained and reasonably used for all in an open condition.
- 42. 43. The boat ramp is for seasonal use, i.e., the ramp is used for the winter storage of the park's floats and gangways and will not be kept clear of snow and ice to facilitate boating operations. Only those devices that will permit a boat to be launched and free floating or recovered without blocking the ramp for more than 20 minutes are authorized on the ramp. Only exceptions to this regulation will be made with advance permission of the Winslow Park Commission.
- 43. 44. Charcoal shall be burned only in grills provided or private grills, and disposed of in designated containers.
- 44. 45. Items of value shall be held in "lost and found" until December 31 of the same year, when if not claimed, shall become Park property.
- 45. 46. Park permission must be obtained for any archaeological activities.
- 47. Camp Seaside parents will be issued a camper pick up pass.
