OTHER BUSINESS:

- 1). A discussion was held on a request for storm drain stenciling. The Council rejected this request by a unanimous consensus.
- 2). Council Chairperson Bradley updated the Council on Residential Waste Disposal Fees Collections and Solid Waste Ordinance Changes. Members of the public voiced their opinions on this subject. After much discussion it was the consensus of the Council to go forward with the original proposals and this matter will be brought back to the Council at a later date. The Ordinance Committee will review proposed amendments to the Solid Waste Legislation and, on August 20, the Council will discuss the implementation schedule and ordinance amendment recommendations.
- 3). Mr. Ken Mann, a member of the public, addressed the Council concerning a proposal for an amendment to the Town Charter. Mr. Mann was upset because the proposal had not been submitted to the Town Attorney for his review when first given to the Town. However, Mr Mann also informed the Council that after a discussion with the Town Clerk earlier that day, the proposal has been sent to the attorney by the Town Clerk.
- 4). Council Campbell familiarized the Council with the issue of illegal dumping of trash & debris on private property on the Pownal Road. The Council decided that more information is needed and this item will come back to the Council on August 20.
- 5). Councilor Goddard requested that the Municipal Facilities Committee report their activities at the next Council meeting.
