OTHER BUSINESS:

- 1). Councilor Grady informed the Council of a presentation of a special citation that was made to the Town of Freeport by the American Automobile Association for Outstanding Pedestrian Accident Record for 1990.
- 2). A discussion was held on a recommendation of the Traffic & Parking Committee for Horse Carriage Rides in the Village Area. The Council would like this issue to go before the Traffic & Parking Committee for further discussion and then be presented to the Council at a future meeting.
- 3). Vice-Chairperson Goddard read the list of Council Sub-Committee assignments for the coming year.
- 4). Chairperson Curtis led the discussion on Council Goals for the coming year.
- 5). A discussion was held on the proposed workshop schedule and locations The Council recommended that some of the workshops should be held in each district. The first being held in District 3 on December 10.
- 6). A request to install a utility pole for electrical service was made by the Freeport Rotary. The Rotary, each Christmas season, sets up and sells Christmas Tree on the Municipal Police Lot to raise money for various community needs and high school scholarships. The request was granted.
- 7). A discussion was held on the purchase of a Christman Tree for the downtown area. The cost would entail delivery of the tree to the area, decorations and disposal. The cost would be \$500. The Council decided not to spend that amount and would like to have the tree set up by the Fire Department, if possible, and have the townspeople or merchants decorate the tree.
- 8). Mary Kennedy, a citizen of Freeport, addressed the Council concerning the drainage problem abutting her Pine Street property. She also expressed concern over her right to install a driveway for an access to Fox Farm Road. This will be discussed at the December 3 Council Meeting.
