FIRST ORDER OF BUSINESS:

MOVED & SECONDED: To waive the reading of the minutes of Meeting #9-93 held April 27, 1993 and accept the minutes as printed. (Councilors Arsenault & Veilleux (7 Ayes) (0 Nays)

SECOND ORDER OF BUSINESS: Public Comment Period - 30 Minutes.

Ken Mann and Mary Kennedy presented an award to Amy Adams for her outstanding citizenship to the Town of Freeport. She has lived in Freeport for more than 40 years and has served on various boards and committees.

Ms. Adams thanked everyone for the award. She mentioned that she has been very upset since she was unjustly accused in a public hearing of contacting a Congressman to appeal that federal funds be withheld for the construction of Alternative Travel Lanes. While she did not contact a Congressman prior to the public hearing, she pointed out that her right to do just that is guaranteed under the Constitution. She feels that the Councilor in question should resign. She indicated that there is a growing feeling amongst Freeport Citizens that the whole Council should resign.

Mr. Al Fagone made reference to an article that appeared in the PORTLAND PRESS HERALD on May 1 and urged Freeporters to get a copy. He urged any officials directly responsible for the misuse of public funds to resign immediately.

<u>THIRD ORDER OF BUSINESS</u>: To take action on the following items of business as read by the Council Chairperson.

ITEM #78-93

To consider action relative to proposed revisions of the Winslow Park Master Plan (Public Hearing)

MOVED AND SECONDED: That the proposed revisions of the Winslow Park Master Plan be subject to Public Hearing: (Councilors Nelson & Veilleux) (7 Ayes) (0 Nays)

Wayne Hollingworth made a presentation on the revision to Winslow Park. It is not a new plan but simply an updating. They are hoping to keep and preserve the park for a number of generations to come in keeping with the rules and regulations set forth in the trust. He mentioned that three people set out to work on these revisions with directions from the entire commission: Carol Burrall, Carmella Barton and Anne Wold.

A slide presentation was made with Ms. Burrall pointing out that there are approximately 92 acres and it is actually used during all four seasons. The Commission feels that the park should abide by the rules of the Town and that the user fees should keep the park self sustaining. Changes to the entry to the boat launch and gate house area are being considered since there is a circulation problem that exists currently. Some consideration is being given to use the farm house for the day camp office. The Commission feels that the park should be more responsible about conforming to Freeport's Zoning requirements for campgrounds. They are contemplating making the sites regulation size and clustering them away from the shore. There are presently 100 sites in the campground but the new plan will reduce the number to 56. The fee structure might need to be changed. As for Harb Cottage, plans are to install plantings enclosing it.

Carla Skiffington asked how many of the sites would be set up for RV's, tents or trailers and Ms. Burrall indicated that this has not been decided yet.

Ms. Burrall was asked why the number of sites was being so drastically reduced. Ms. Burrall indicated that the zoning rules justified reducing the number and that the commission feels that the park should be designed for the citizens of the Town of Freeport and the majority of Freeport residents do not camp. She indicated that the commission is aware that there will probably be a reduction in revenue. Councilor Bradley indicated that he would like to see a qualitative analysis.

Councilor Arsenault indicated that the more expensive water-front lots probably make up a large percent of the park's revenues and doing away with them would probably cause a greater impact than is expected. He mentioned that campers buy ice, maps and items that tenters do not purchase. Putting a wide road between the sites and the water would probably make them less desirable. Councilor Arsenault pointed out that half the houses in Freeport are non-conforming and he is not aware of any action in the works to make everything conforming. He indicated that there is no legal requirement to move the

water sites. He proceeded to read four affidavits from Paul Powers concerning the reduction of camp sites assuring that there will always be clear views of Casco Bay for park users. After reading Mr. Powers' statements, Councilor Arsenault indicated that when he sees the attempt to eliminate waterfront camping being considered, he is appalled that anyone would willingly jeopardize the park being lost. Councilor Arsenault indicated that with the obvious fee hike, he is fearful that the park will turn into a "yuppy day park" because only people with a lot of money will be able to afford to go there and camp.

Charles Gould pointed out that the new plan makes the park a higher quality park for everyone to use. Mr. Hollingworth advised that pushing the sites back 40' from the water will give the campers more protection from the day users. which is something campers have stressed in the past.

Ruby McDermott indicated that the sites located on the new plan were not attractive for tenting. She too is concerned with the price increases.

David Stilkey mentioned that he has camped there since he was a child up until the park stopped allowing seasonal camping which he feels is the reason Freeporters do not camp in this park. They were told they would have to move at the end of each two week intervals. Even the Fire Department was told they could not continue to have their annual picnic there because someone might drink a beer and this is no longer allowed. He is offended that the Commission reports that no Freeporters use the campgrounds, when he and his wife actually camp there as is the case with some of his friends. He indicated that he is curious as to how much the whole master plan will cost.

Comments were received from Amy Adams, Bill Ross, Andy Cadot, Leon Arsenault, Walter Christie, Kevin Zorsky, and Ken Mann.

Esther Hughes indicated that she uses the park on a regular basis and liked the revisions being considered. She pointed out that the commission needs to better advertise the meetings. She is certain that many more people will come to the meetings. Ms. Burrall advised that they are held on the third Monday of each month at 7:30 p.m. in the Council Chambers. Jim Hughes added that this plan provides a good mix for users.

Mick McGivern advised that he provided copies of the letters received from Paul Powers to the Town Manager and to the Recording Secretary and requested that they be entered into the Council minutes since Mr. Powers has had to state no less than four times, the conditions of the trust. He warned that one of the Councilors who also serves on the Appointments Committee has handpicked a Winslow Park Commission who will eventually remove all camping and recreational vehicles from the park either by land use regulations or by pricing them out. He urged the Council to reject the proposal to reduce the number of campsites.

Mr. Hollingworth pointed out that an open house is scheduled for June 5 and invited everyone to come out and use the park. He thanked the Boy Scouts for their planting help.

ITEM #78-93 MOVED AND SECONDED: To close the public hearing (Councilors Nelson and Veilleux) (7 Ayes) (0 Nays)

Councilor Bennett asked what impact will the changes have on the right-of-way for the private property owners at the end of the park. Ms. Burrall indicated there would be no change. Councilor Bennett asked if changing the roadway has been discussed with the private property owners. Ms. Burrall indicated that the answer was no.

Councilor Bennett asked if balance of surplus money has been increasing and was told that it has been increasing but no one has any exact figures. Councilor Bennett indicated that he would like to see a financial analysis. Chairman Goddard indicated that this should be turned over quickly. Councilor Bradley indicated that he too would like to see the actual analysis since he would need to see how they could sustain their ongoing facilities.

Ms. Burrall indicated that their proposal was conceptual and that they would have to hire a specialist to come up with the costs of the changes. Councilor Bradley indicated that they should come up with a time table for their proposal. Councilor Bradley indicated that the Commission and the Council should schedule a workshop and discuss the issues that were brought up tonight. Mr. Gould indicated that he and the Commission would really appreciate receiving some encouragement and prioritization from the Council.

Councilor Nelson indicated that he has always meticulously followed good planning. He feels that it is an affront to say that the commission follows his dictate when they actually disagree on a number of occasions. He hopes that everyone will take a careful look at the plans which were done by professionals and will provide quality use of the park by all people.

Councilor Bennett asked about the setbacks that are required for campgrounds now. David Thompson indicated that if a use is vacated for a year and a half, the grandfathered status is lost but as long as it is maintained, the status will be forever.

Councilor Ruff thanked the commission for all their efforts in coming up with this plan and indicated that a possible time frame for implementing this plan should be submitted. She is sure that day use has increased dramatically over the years and improvements need to be made for this area as well as the campground.

Councilor Arsenault asked if the final vote couldn't be put off until sometime in June when Paul Powers will be back from Florida. He feels it is important to have Mr. Powers sit down with the Council and the Commission and discuss the 1993 terms. Chairman Goddard indicated that this should be discussed at next week's workshop and Councilor Nelson agreed with this concept.

Councilor Bennett asked if access to the boat ramp would still be available off season and was told that it would be accessible by Ms. Burrall.

Update on Harbor Master's Boat Purchase

Jay Pinkham explained that Coastal Waters has allocated \$12,000 for the purchase of a boat. for the Harbormaster. He has found a 20' Seaway with a 115 Johnson on it for \$8,200. The motor is an '81 and Councilor Bradley cautioned that someone should look at the cylinders since these engines were designed for fuel with additives.

Mr. Pinkham advised that Brewer's from South Freeport will be checking it over. He has looked into the price of new outboards.

He is proposing to purchase the boat package for \$8,200 and will sell the 16' Boston Whaler and trailer (it might be worth up to \$4,000). He would like to keep this money in escrow for the future purchase of a new outboard. Upon passing the testing and inspections, he would request approval by the Council.

Councilor Bennett indicated he would like to see prices on new motors before he approves anything. Councilor Arsenault indicated that he is concerned with buying a ten year old motor and then having to buy another motor.

The Council concurred that this purchase would be okay.

Chairman Goddard mentioned the Petition Committee and the petition request, and wanted to go on record that it is his opinion and the Town Manager's opinion that there were no problems encountered in dealing with the petition request. Councilor Arsenault advised that the Town Clerk is capable of typing this sort of request.
