SECOND ORDER OF BUSINESS: Public Comment Period - 30 Minutes.

Caroline Thorne-Lyman, a member of the Advisory Board for ATL's pointed out that while on a site walk reviewing the Alternative Travel Lane on Lower Mast Landing Road she was subjected to profanity and she did not enjoy the negative attitudes that prevailed. As a volunteer, she wanted to know if she had any recourse to this type of behavior. She urged citizens to come forward and talk to the Councilors.

Al Fagone pointed out that the previous speaker failed to mention that some of the profanity was used by a Town Department head. He read a segment of the Town Charter referring to the Town Manager. He feels the Town Manager condones abusive language and hostility against the residents of Freeport by his department heads by not taking any action.

Councilor Bradley pointed out that there is a limit to what a person has to take in response to Ms. Thorne-Lyman's question. The Council has been pushed to the limit this year. Some individuals think that because they are private citizens, they can say or do anything. He indicated that he would continue to absorb it, because he feels it is part of the job. Just because people get away with it, doesn't make it right.

Ed Campbell indicated that he supports the 500 employees of the town. He does not condone people standing anyone up for a public flogging. While he feels he does not need to urge support for the school staff, he feels there should be more support for the Town Manager and his staff. He urged people to stop complaining and get involved. Consider running for the Town Council.

Barbara McGivern advised that she feels the rhetoric on everyone's part has reached an all time low this year. She is not anti-school or anti-education but feels that the language allowed at the High School should be looked at.

Item #112-93

To Consider action relative to the Regional Vocational Budget as approved by the Cooperative Board for the year 1993-1994.

Chairman Goddard explained that this is the beginning of the discussion of the budget and this is the opportunity for people to make comments on the budget as a whole. He urged that comments be kept brief. He pointed out that the budget process this year has been extremely open and has allowed people the opportunity to get involved in finding out about the budget and giving input.

Barbara McGivern pointed out while the elderly have programs to help them stay in their homes, she is concerned that there are no programs to help with tax relief for people in their 20's, 30's, 40's and 50's. Taxes are doubling every six or seven years and she feels government is growing too fast.

Mary Kennedy feels that the budget process was not as open as previously stated. At some meetings public comments were not allowed. Some meetings were held during the day and the public was not able to attend. Her interpretation of what is happening is taxation without representation.

Amy Adams had some observations to share on Council Workshops. She feels it is urgent that a Council Advisory Council Budget Committee be created due to the behavior of some of the Councilors at the workshops. She feels that unnecessary dollars are being spent and these dollars could have kept the tax rate down. She mentioned the possibility of a charter amendment to be voted on in November. She pointed out the possibilities of other changes such as the budget being approved by the citizens, The Town Manager, Superintendent of Schools and Town Clerk could be elected positions and their terms could be limited. She feels that referendums have a real place in government.

Madeline Baker pointed out that she feels that the salary increases being proposed are excessive for the School Administration and the Town Manager and his staff. She had some questions regarding the full value tax rates and is concerned about the debt service. She feels that the three minutes allowed for public comments does not allow taxpayers enough time to get their questions answered.

Edith Curtis mentioned that she is a senior citizen whose taxes were raised 300% last year. She did get them dropped so that the increase was 200%. She feels taxes should not increase when there is no increase in services. She mentioned that two of her neighbors have had to sell their homes and move out of town. She feels that senior citizens are just as important as children. She asked if there was some way to cut the cost of education and if there was some way to limit the amount of money being spent on streets. She asked if there was any other way of raising money other than raising taxes on people with fixed incomes. She urged the Council to start considering the residents whose families have been here for hundreds of years.

Ken Mann indicated that many have come to the meeting tonight in a peaceful protest of the proposed budget since it contains more than one million dollars of new spending increases over last year. This is a small town with 6,000 people. The 6.9% increase in the property tax rate is a repressive tax. In Boston in 1773 our forefathers dumped tea into Boston Harbor to protest excessive tax. He indicated that he had bags of tea to distribute to members of the public who are opposed to this increase in property taxes. He indicated that people should leave the bags of tea on the barrel that was placed in the Council Chambers as a means of notifying the Council that they are dissatisfied with the budget, the budget process and the property tax. He added his bag of tea to the barrel and asked people to join him and then exit the room.

Peter Moulton advised that he had been greatly upset by a comment that was made at last week's Council meeting. A gentleman made a statement that anyone opposed to the school budget is very selfish. He is opposed to the budget because he feels there are cuts that could be made and not because he is selfish. He feels that the plan of the Council adding money to the School Budget without going to the School Committee indicates that the Council doesn't feel the School Committee has done a good enough job.

Donna Devaudreuil indicated that she feels the budget process allowed her to get her questions answered and supports the budget as presented at the public hearing.

Councilor Arsenault indicated that he too wanted to exercise his right to protest the budget. He is aware that the majority of the Council has voted by consensus and has decided that the taxpayer's pockets are bottomless. He is fearful that the young people and elderly people in town will not be able to afford to continue to live here. He feels the Council should have prioritized and not voted for everything. His protest is to leave and not vote on the budget. He indicated that his vote is a no vote if the Council wants to count

it. Chairman Goddard indicated that if Councilor Arsenault is not present, he will not vote and he is sorry to see him leave.

BE IT ORDERED: That the Regional Vocational Budget as approved by the Cooperative Board for the year 1993-94 be approved in the amount of \$1,382,308 and that \$198,746 be appropriated as Freeport's local share. (Councilors Nelson & Ruff) **ROLL CALL VOTE:** (6 Ayes) (0 Nays)

1. Discussion on providing a Library Building Security System.

Mr. Olmstead explained that the Library recently experienced a break in and a sum of money was stolen from their cash box. As a result, the Library has increased the frequency of depositing cash into the Town's bank account. While the amount was relatively small, a greater damage could have occurred. This is the only municipal building that does not have a security system in it. The lowest quote received to date is \$1,165 for a security sustem. Currently the Council Chair and Vice Chair is authorized to allocate that funds be taken out of the Contingency Account and simply notify the Council. Chairman Goddard indicated that he wanted to get a consensus from the Council. The Council's consensus was that a security system should be purchased.

MOVED & SECONDED: That the Council authorize the Chair and Vice Chair to make a decision on the best offer that would provide what is needed for security at the Library. (Councilors Ruff & Veilleux) (6 Ayes) (0Nays)
