- 2. Chairperson Beaulieu, LB-C3 Committee, stated that the committee will be meeting January 22 and is hoping to bring something forward this summer. She added that George Fraser has agreed to chair this committee. All land abutters will be asked to participate in this effort.
- 3. Councilor Soley stated that the Community Development Committee is considering forming an independent, non-profit corporation, with a balance of representatives of councilors and business members, to fit into the Economic Development group.

Chairperson Beaulieu stated that they need to bring something forward before the beginning of the budget season. The committee has talked to economic development groups in Scarborough, Gorham and Portland, to see how the other town progress, etc.

Councilor Mann asked for clarification as to how the \$25,000 appropriated for economic develop in the budget has been used.

Chairperson Beaulieu stated that the funds have been used for Jack Lufkin, who has been working on the community development aspects, basically doing the legwork of gathering information from other communities.

Councilor Campbell stated that Mr. Lufkin has been framing out a mission statement, goals, etc., and how this should be built.

Chairperson Beaulieu stated that the there will be a meeting this Friday at 1:00 P.M. to review the document to see if it is worded as it should be.

4. Manager Olmstead listed the upcoming subcommittees' meetings, Special Projects, Appointments, Ordinance and Municipal Facilities.

Councilor Bishop stated that people interested in any of these committees are welcome to attend. It is fair that people who have expressed interest should have the opportunity to serve.

Councilor Soley suggested that people who are not reappointed should be called.

Re: High Street

The short section of High Street which is a Town road has long been a maintenance headache for Public Works. In working out the details of their housing development with Freeport Housing Trust, I have suggested that they take over this short section of Town road. They have agreed to do this, and the development plan approved by the Planning Board assumes that High Street will become the project driveway.

I would therefore request that you petition the Council to abandon High Street and turn over ownership of the land under the street to the FHT partnership which owns the housing project. The ownership entity is Freeport Affordable Housing, L.P. The only other property effected by this abandonment is the house in back of the project, 20 High Street. This house is now owned by the Housing Trust. Since all concerned parties are in agreement with the proposed change, their should be no opposition to the Council taking this action.
