### ITEM #169-97

To consider action relative to a Moratorium on the Construction, Erection and Location of Transmission Towers.

WHEREAS: The Town Council finds that the Freeport Zoning Ordinance currently permits the location of telecommunication towers, broadcast towers and other types of transmission towers throughout the town but contains almost no regulations, such as height limits, construction standards, siting criteria and safety standards, which would ensure that such transmission towers are placed only in locations where they will be compatible with adjacent land uses and will not have adverse visual impacts or negative effects on property values; and

WHEREAS, the granting by the Federal Communications Commissions of licenses for a number of "personal communication services," which requires smaller geographic sections or "cells" than existing cellular telephone technology, has created a significant demand for new transmission tower locations, and Freeport appears to be so situated that operators of the personal communication services are likely to seek sites in the town; and

WHEREAS, the Town Council finds that the application of the Town's existing Comprehensive Plan, Zoning Ordinance and other applicable laws and

regulations is inadequate to prevent serious public harm from a land use which is now virtually unregulated; and

WHEREAS, the Town Council is directing the Freeport Planning Board to develop appropriate regulations to govern the location and construction of transmission towers; and

WHEREAS, it would be detrimental to the public health, safety and welfare to allow the uncontrolled and unregulated location and construction of transmission towers until the Planning Board can complete its work of developing adequate regulations; and

NOW WHEREAS, the Town of Freeport hereby ordains as follows:

- 1. <u>Construction and Location of Transmission Towers Prohibited</u>. During the period of time this ordinance is in effect, no person shall erect, construct or locate any transmission tower in the Town of Freeport.
- 2. <u>Acceptance of Applications Prohibited</u>. During the time this ordinance is in effect, no officer, official, employee, office, board or agency of the Town of Freeport shall receive, accept or act upon any application or act upon any application or grant any permit, approval or permission to erect or locate a transmission tower in the Town of Freeport.
- 3. <u>Definition</u>. "Transmission Tower" means a structure used for the wireless transmission or reception of electric impulses or signals by means of electromagnetic waves, including any such structure which may also be classified a "public utility facility" under the Freeport Zoning Ordinance. The term transmission tower does not include home television antennas, satellite dishes or similar structures accessory to a dwelling or business.
- 4. <u>Applicability</u>. Notwithstanding anything to the contrary in 1 M.R.S.A. Section 302, this Ordinance shall apply to any applications or requests to erect, construct or locate a transmission tower submitted to the Town of Freeport on or after March 18, 1997.
- 5. <u>Effective Date and Duration</u>. This Ordinance shall be in effect from the date of adoption until February 28, 1998.

Chairperson Beaulieu stated that Councilor Mann was excused. His mother passed away on Saturday and the visiting hours are this evening. She added that our thoughts are with him.

Manager Olmstead stated that the exhibit is attached to the Minutes in the Clerk's Office, and has been filed in the Registry of Deeds.

**VOTE ON THE MINUTES AS AMENDED**: (6 Ayes) (1 Excused-Mann)

Chairperson Beaulieu stated that she wished to take a moment of silence to recognize Carol Kaplan who passed away quite suddenly. She had been with the Town for over 16 years as Welfare Director and had led an extraordinary life. She stated that several other people in the Community who did a lot had also passed away this week.

Councilor Campbell stated that Carol Kaplan was a tremendous asset to this community; he will miss her very much.

# **SECOND ORDER OF BUSINESS: PUBLIC COMMENT PERIOD**

- 1. Stan Davis, 103 Hunter Road, stated he wished to speak about a 1939 American LaFrance the Town purchased during the Depression. The Fire Department would have loved to restore this; next year is the Department's 100<sup>th</sup> Anniversary. We felt it would be an honor for all of the fire fighters to see this (truck) in the parade next year. He stated that a donation of \$25,000 had been received; shortly after, we approached the Council for permission to do a fund-raiser, and he thanked the 7 Councilors for granting this request. The Historical Society offered to help with the fund-raiser, putting out a flyer regarding this. We contacted Fire Fly Restoration Company, in Hope, ME, one of 2 people in the world approved to restore fire apparatus. Funds started coming in on a daily basis, until a bulletin came out from the "Voice of the People" misquoting Council action regarding this issue; after this, the funds stopped coming. Mr. Davis requested that the publishers of the bulletin apologize to the Town Council, the Fire Department and the Citizens of the Town of Freeport.
- Raymond Smith, 3 Lajoie Drive, re: restoration of the fire truck fund-raiser, stated that he wished to address the public about what is going on, in order to clarify any (misconceptions). The fire fighters are proud of the organization they belong to and the history of the Department; they will be celebrating their 100<sup>th</sup> anniversary and would like to have this piece of equipment restored for this event. The check for \$25,000 was never given to the Town; it was written out to Fire Fly Restoration, which was done to keep the donor's name confidential as requested. He stated that there is an agreement between Andy Swift of Fire Fly Restoration and the Fire Department that states the restoration that will be done on the 1939 American LaFrance vehicle with the approval of the Fire Department. He stated that the "Voice of the People" should have stated that the Town Council authorized the Fire Department to proceed with the fund-raiser for the purpose of

restoring the 1939 American LaFrance. He added that (donation) checks should be written to either the Town of Freeport or the Fire Department.

- Chief Daly stated that if anyone who wishes to keep their donation anonymous, their checks can be made out to Fire Fly Restoration, put in a sealed enveloped and dropped off at the Fire Department. These sealed envelopes will be handdelivered to Andy Swift.
- 4. Councilor Bishop stated that she is not running for re-election to the Council this year; the reason she ran (for office) previously was to get involved in town government and to help. She raised concern for the treatment she has received including insults, threatening letters and criticism. Of great concern to her is the way the campaign is going this year, including the "Voice of the People" flyers, that do not represent an honest voice of the people. She urged people to find out the facts for themselves the fire truck restoration project is a perfect example of misinformation. She added that it is illegal to put flyers in mailboxes. She stated that the flyers attacked affordable housing, enforcing laws regarding trash, etc. She stated that the Town has never had an 11% tax increase in 16 years. She requested that people compare Town salaries to those of other towns before criticizing ours.
- 5. Ken Guimont stated that he wanted to apologize to the Council for what is happening in our Town, such as the type of attacks that are appearing in our mailboxes, which are disheartening and atrocious, and reflect upon the people writing these. He stated that he recognizes the hundreds of hours the Council spends in managing the Town for our elderly our children and us. He feels that he is speaking for many citizens who share his beliefs. He feels bad for the Town.

Chairperson Beaulieu thanked Mr. Guimont for his comments, adding that it has been amazing to her the number of people who have approached her with similar feelings.

6. John Lowe, North Freeport, stated that the restoration of the 1939 truck is being done solely through donations and asked the citizens to donate what they can. He confirmed that no tax money is being used.

Councilor Soley stated that he opposes this for two reasons, Article 1.1 takes out language which is necessary for legal reasons, and second, 2.3.d. subverts the purpose of this policy. His concern is that this will raise the opportunity for favoritism.

Councilor Hindley agrees but feels that there are different situations which develop for different reasons (and taxes are not paid), etc.

Discussion followed re: not wishing to take people's property, residents having the existing opportunity to make payment plans, 3.5 years to pay taxes, etc.

Councilor Soule stated he does not support this amendment, in that the language does not provide protection to residents.

1. Report from the Municipal Facilities Committee on review of the Pownal/Freeport boundary lines.

Councilor Soley reported on the meeting held with two selectmen from Pownal and the Chair of their Planning Board, who pointed out that there is a boundary line to be walked every 10 years. They requested that Freeport pay half of the cost to do this.

Councilor Campbell stated that this issue was revisited years ago; accuracy is in demand; he supports this.

Chairperson Beaulieu stated that if it makes good citizenship, we should do it.

 Councilor Hindley suggested a workshop be scheduled for the public to discuss the issue of paper streets, in order to develop a charge for the committee.

Chairperson Beaulieu stated that she understood the charge was to decide which paper streets they wanted to keep or not keep.

Councilor Soley stated that his understanding was that they will divide the Town into areas and review.

Manager Olmstead stated that the Appointments Committee would recommend a list of people to serve on this committee, which will come to the Council at its next meeting. He agrees that there ought to be a workshop so the Council can have a discussion with this newly appointed committee, (including) a written charge outlining the process which will unfold in a certain way. Once we get through the election, we can schedule a workshop with the committee. The Appointments Committee decided to have 7 members and 1 alternate on this committee.

Discussion followed re: size of committee, charge of committee being in writing, etc.
