Chair Arsenault called the meeting to order at 7 p.m.

FIRST ORDER OF BUSINESS: To waive the reading of the Minutes of Meeting #4-2003 held on March 11, 2003 and accept the Minutes as printed.

MOVED AND SECONDED: TO WAIVE THE READING OF THE MINUTES OF MEETINGS #4-2003 HELD ON MARCH 11, 2003 AND ACCEPT THE MINUTES AS PRINTED. (Councilors Cassida & DeGrandpre) VOTE: (6 Ayes) (1 Excused—Rumpf).

SECOND ORDER OF BUSINESS: Public Comment Period – 30 Minutes (Non Agenda Items Only)

MOVED AND SECONDED: That the public comment period be opened on Non Agenda Items only. (Councilors Cassida & DeGrandpre) (6 Ayes) (1 Excused—Rumpf)..

Russell Baker asked if Councilors are phoning members of the public seeking input and if not, he would like them to contact people that are unable to attend meetings. He wants the Council to maintain an open door policy for Council meetings and would like to see a freeze on taxes for the next four years. He noted some safety concerns he has with crosswalks and also that some people do not use them. He noted the need for handicap parking in front of L.L. Bean or Dansk. He pointed out the safety concerns he has at the new proposed Shaw's facility. He also would like to see small businesses have kiosk signs in downtown Freeport advertising their businesses. He questions why tax money is allocated to FEDC and their use of Town facilities for meetings. Chair Arsenault noted that the Council is not supposed to respond to questions during this part of the meeting. Mr. Baker also would like to have a print-out of properties included with the tax bills to ensure that people are being taxed correctly. Mr. Baker also had a few suggestions for

cutting taxes.

Councilor White informed Mr. Baker that members of the public should feel free to call him at any time and his phone number is 865-4749. Mr. Baker provided a written copy of his questions and concerns to the Council.

Genie Beaulieu, a former member of FEDC, explained that it is comprised of the Town Council and they appoint a Board of Directors. The Town Council runs FEDC and that is why the money comes from the Town. It is not an organization of business. Councilor Regier noted he sits on the Board and that a FEDC Report is being prepared right away.

Councilor Regier advised that the Parking and Traffic Committee is working on crosswalk safety and lighting and are also trying to get an inventory of handicap spaces right now.

MOVED AND SECONDED: That the public comment period be closed. (Cassida & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

### **ANNOUNCEMENTS**

Chair Arsenault advised that the Town Council will invite members of the Shellfish Commission as well as Sewer District Trustees to a workshop on April 1 at 8 p.m. to discuss closures of shellfish harvesting areas. Dye testing will be done.

Chair Arsenault noted that a report has been received from Dick Bradbury, State Entomologist, and there is a description of where the worst infestation of Browntail Moths will take place this year on the Freeport Website. Again it appears that along the waterfront will be the worst infestation. Councilor Regier reported on his own testing.

Chair Arsenault noted that there is a bill in the U.S. Senate right now to take the big trucks off of Route One by imposing a weight limit of 80,000 lbs. on Route One and put them out on the Interstate.

Chair Arsenault noted that there will be a workshop for planning a Vibrant and Prosperous Downtown Village on April 12, beginning at 9 a.m. at the Freeport Middle School. Citizens are urged to rsvp to Mary Lou Haller at the Town Office because there will be food served.

Chair Arsenault also advised that there is good news in the fact that the Grant Road property has been finalized and the Town now owns it. The closing took place last Friday. He thanked everyone involved.

Chair Arsenault pointed out that there will be a Town Council Workshop on March 31 at 6 p.m. at the Freeport Community Library regarding Town Council Orientation. He requested that Councilors bring their Big blue binders

THIRD ORDER OF BUSINESS: To take action on the following items of business as read by the Council Chairperson:

ITEM #32-2003 To consider action relative to adopting the March 25, 2003 Consent Agenda.

BE IT ORDERED: That the March 25, 2003 Consent Agenda be adopted. (Cassida & Regier) ROLL CALL VOTE: (6 Ayes) (1 Excused—Rumpf).

ITEM #33-2003

To consider action relative to a proposed amendment to the Administrative Code concerning Planning Board reporting to the Town Council (Chapter 2) (Public Hearing)

MOVED AND SECONDED: That the Public Hearing be opened. (DeGrandpre & Regier) (6 Ayes) (1 Excused—Rumpf).

Chair Arsenault explained the amendment and read the new verbiage. There were no public comments.

MOVED AND SECONDED: That the Public Hearing be closed. (Regier & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

**BE IT ORDERED**: That the proposed amendment to the Administrative Code be approved. (DeGrandpre & Bishop)

Councilor DeGrandpre shared his views. Councilor Bishop noted that the Planning Board provides agendas and minutes regularly.

ROLL CALL VOTE: (6 Ayes) (1 Excused—Rumpf).

To consider action relative to amendments to the Sign Ordinance concerning political signs (Chapter 23). (Public Hearing)

Chair Arsenault explained the amendments and read the new verbiage.

MOVED AND SECONDED: That the Public Hearing be opened. (Regier & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

Genie Beaulieu asked for clarification on the timing and Councilor Regier addressed her question. Councilor DeGrandpre pointed out that permits are required before signs can be erected.

MOVED AND SECONDED: That the Public Hearing be closed. (Cassida & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

**BE IT FURTHER ORDERED:** That the proposed amendments to the Sign Ordinance be approved. (Regier & Bishop) **ROLL CALL VOTE:** (6 Ayes) (1 Excused—Rumpf).

ITEM 35-2003

To consider action relative to a proposed amendment to the Traffic & Parking Ordinance concerning a seasonal 48-hour parking zone at the Park & Ride Lot near Pine Street (Chapter 48) (Public Hearing)

MOVED AND SECONDED: That the Public Hearing be opened. (White & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

Jim Plummer explained the reasons for this amendment—people are leaving their vehicles too long during the winter and it is difficult to plow and maintain the area after ice builds up. Rodney Curtis asked if this would pertain to tractor trailer trucks and was advised that the 48 hours will apply to all vehicles by Mr. Plummer.

MOVED AND SECONDED: That the Public Hearing be closed. (White & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

Fuffer & Parking

BE IT FURTHER ORDERED: That the proposed amendments to the Sign Ordinance be approved. (Regier & Bishop)

Mr. Plummer was asked to where the cars would be towed. Mr. Plummer noted that he would have to check with the Police Department.

ROLL CALL VOTE: (White & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

**ITEM 36-2003** 

To consider action relative to adopting a Five Year Capital Plan and approving a Capital Budget for Fiscal Year 2004.

MOVED AND SECONDED: That the Public Hearing be opened. (Bishop & Cassida) (6 Ayes) (1 Excused—Rumpf).

Chair Arsenault pointed out that copies of the Plan are available for members of the public. Rodney Curtis of Oak Avenue called the Council's attention to page 8 of the Capital Town Improvements where the Oak Street Drainage/Reconstruction is planned for 2007. He recalled what was said at a Council meeting a year ago. He had drainage pictures to share. Genie Beaulieu recalled that this problem was included in the capital plan to be fixed this year and encouraged Councilors to move it back to '03. Jim Plummer explained that the South Freeport Road Reconstruction is already funded by a State grant and Plummer explained. He noted some of the unknowns that exist with the Oak Avenue Town money combined. He noted some of the unknowns that exist with the Oak Avenue Drainage/Reconstruction. He has been working with the Town Engineer. They have ordered a special cover and will be putting it in place soon. He suspects that the Oak Avenue project can be corrected in '04. Discussion followed. Councilor Regier offered to check with the Town Manager upon his return tomorrow regarding timing and money to see what is possible. When this plan is adopted next week, Councilor Regier promised an amendment.

Barbara McPheters representing the Friends of Freeport's Cemeteries referred to a long-range plan that was provided to Councilors. \$10,000 is being requested again this year. She explained what this money will be dedicated to. She offered to answer questions.

Chair Arsenault thanked Ms. McPheters for what she has done for Freeport cemeteries. Genie Beaulieu asked if any requests for inmate labor from Cumberland County has been considered. Chair Arsenault agreed that this would be a good year to do this.

Bob Lyman provided information on repairing the public tennis courts. To regrind and resurface would cost \$50,000 but they are looking to provide a layer in the cracks and over the cracks, and other small repairs which would reduce their request from \$25,000 to \$15,000. They expect to get another 10 years in use.

He addressed the warranty on the roof. He was asked why there was only a 2 year warranty. Now they have a 20 year warranty but it cost them \$500 which is money well spent.

MOVED AND SECONDED: That the Public Hearing be closed. (Regier & DeGrandpre) (6 Ayes) (1 Excused—Rumpf).

MOVED AND SECONDED: That Item #36-2003 be tabled until April 1, 2003. (Bishop & Cassida) (6 Ayes) (1 Excused—Rumpf).

ITEM 37-2003

To consider action relative to the Tax Policy for Fiscal Year 2004.

**BE IT ORDERED:** That the tax policy be waived for 2004 to provide for a tax rate lower than allowed under the policy.

BE IT FURTHER ORDERED: That the tax rate be increased only to cover both voter approved and council approved debt, an increase in County Tax and an anticipated loss in state subsidy for school operating expenses (estimated loss \$102,500) (projected increase 2.75%).

NOTE: this item was requested by Councilor Arsenault. (Cassida & DeGrandpre)

Chair Arsenault explained that there were three items included in this suggested increase—1) the bond issues for the schools, 2) the increase in the County tax and 3) is the estimated loss in State subsidy to the schools. This will equate to a \$.50 mill rate increase per thousand. The Council has worked hard to keep the tax rate under 3% this year, taking into consideration the re-val and its effect on citizens. The Schools have worked diligently with the Municipal side to make this slight increase possible this year. Councilor Regier pointed out that the Council is waiving any inflation increase this year. Discussion followed.

ROLL CALL VOTE: (6 Ayes) (1 Excused—Rumpf).

ITEM #38-2003

To consider action relative to adopting an Emergency Operations Plan for the Town of Freeport.

BE IT ORDERED: That the Emergency Operations Plan for the Town of Freeport Dated 2003 be adopted. (DeGrandpre & Bishop)

Chief Fournier noted that he is looking for a positive vote. He mentioned that Department heads would be provided with condensed versions. Chief Fournier advised that copies of the whole Plan will be provided to all Councilors but condensed copies could be provided as well.

ROLL CALL VOTE: (6 Ayes) (1 Excused—Rumpf).

ITEM #39-2003 To consider action relative to approving a lease agreement for a portion of the Dunning Boatyard Property.

BE IT ORDERED: That the proposed lease agreement between the Town of Freeport and Carter Becker d/b/a Falls Point Marine, dated April 1, 2003 be approved. (Regier & DeGrandpre)

Councilor Regier noted that further discussion with the Municipal Facilities Committee needs to take place and he requested that this be tabled to the next meeting on April 1.

MOVED AND SECONDED: To table until April 1. (Regier & DeGrandpre) VOTE: (6 Ayes) (1 Excused—Rumpf).

#### OTHER BUSINESS:

 Presentation on proposed improvement to the Green Space at the corner of Main and West Streets—George Denney.

George Denney of the FEDC introduced Rita Armstrong and proceeded with a PowerPoint presentation showing what has been done throughout the Town. He explained that they are planning to beautify this area near the Public Safety Building by constructing stone walls, installing had railings, a hand-carved sign, a memorial and planting flowering trees, shrubs, perennials and annuals. He asked that the Town provide the labor for digging the area out for the stone walls. He has spoken to Jim Plummer. Benches are not included in this proposal this year because of budget restraints. Councilor White asked what plantings are proposed. Ruby McDermott explained that six crabapples, flowering shrubs, perennials and annuals that will provide a lot of color. Mr. Denney asked for Council approval to begin the project.

Councilor Regier asked Mr. Denney and Mrs. McDermott to share the heights and location of the proposed plantings with the Police Chief and Town Engineer to evaluate sight lines and traffic safety. Councilor Regier saluted Mr. Denney for leading this effort. Mr. Denney noted all the people involved in this project. Councilor DeGrandpre suggested advertising the work days to see if volunteers could be obtained and Councilor Bishop suggested putting the days on the cable TV and on the Town's website. Next step will be Judy Hawley checking with Fred Reeder to see if Design Review needs to look at the sign. Councilors concurred that the committee should contact the Town Manager before proceeding. Councilor White noted the unsightly area near the railroad tracks. Discussion followed. Chair Arsenault thanked Mr. Denney for his vision and all the people involved.

- 2. Announcement of workshops on Maine's Freedom of Access Act—Judy Hawley noted that the Town will be hosting two sessions for Town employees with the Town Attorney on retention and public access which is in response to Maine's Freedom of Access Act on April 3. One session will be at 10 a.m. and the other will be at 1 p.m. Councilor DeGrandpre asked if he could attend and was told that he could. These sessions will be taped so that an employee can watch it if they are unable to attend.
- 3. Discussion on the potential of joining the Maine State Retirement System—Greg L'Heureux. Mr. L'Heureux explained the pros and cons of rejoining the Maine State Retirement System. He noted that the fund is managed very well and is reviewed yearly. Councilor Regier asked what the impact would be on the Town's budget. Mr. L'Heureux did not know because he did not know how many would switch. Councilor Regier asked him to work through some cost projections in the event the Town pursues rejoining. He is also interested in knowing what type of external review there is. Discussion followed.

Chair Arsenault thanked Mr. L'Heureux for the presentation. There was consensus to move forward and gather more information. A workshop will be scheduled in late April or early May.

4. Town Council Informational Exchange

Chair Arsenault had a handout on goals and explained that he worked with Vice Chair Regier and they tried to include everybody's ideas. He asked that everyone review them.

#### **Proposed Council Goals 2003**

- 1. Control tax increases.
- 2. Continue to explore and support regionalization of public services.
- 3. Support Economic Development in an attempt to increase the commercial tax base (focusing particularly on the existing village commercial core, on the Eastland Shoe properties, and more broadly on small businesses in general).
- 4. Continue to pursue growth management efforts, balancing residential growth with public infrastructure costs and the preservation of open space.
- 5. Review Town-owned properties for cost effectiveness and appropriateness of use.
- 6. Pledge that Council members and public employees will be responsive to both individual and community needs.
- 7. Improve dialogue with the School Committee and continue support for quality educational

#### Regionalization

Councilor DeGrandpre updated the Council on a Regionalization meeting he attended last week. There was representation from all towns. At the next meeting they are hoping to have 3, 4 or 5 consultants to take a look at. Attorneys on the committee are going to bring in suggestions for governance models. As he gets more information, he will share it with Councilors.

8. Small businesses, like camping areas, etc., should be able to have signs with their names, their locations, and what they offer, within the perimeter of the town, just as L. L. Bean and Winslow Park are allowed to have. Also, can the council tell us how much of our tax money is being given each year to the Freeport Economic Development Corporation, that was founded by Ed Bonney? I understand that it is \$90,000., and that they also are given free space at the Town Hall for their meetings. is this true? if so, most people in Freeport, don't know much, if anything about this. I also understand the FEDC, is a nonprofit organization and therefore, they say they do not have to say what they are spending this \$90,000, on. It is, after all, our tax money. We have a right to know where it is going and be able to say if we want to give that much and see our taxes rise, yet again.

At tax time, when the tax bills are sent out, there should be included, a printout of what the taxpayer is being charged, to make sure we are not being taxed for things we do not have.


Finally, I ask all taxpayers to speak out and be heard. If you can not come to the council meetings, pick up the phone and call the




#### FREEPORT SIGN ORDINANCE

#### **CHAPTER 23**

#### Section 3. Temporary Signs.

- 3.2 Temporary Political Signs Temporary political signs on public property or within public rights-of-way shall be permitted for a period of fourteen (14) days before the election date to which the sign refers and must be removed within twenty-four (24) hours after the election has occurred. The maximum size of temporary political signs shall be 4 feet by 4 feet. The Codes Enforcement Officer shall specify the date and time that signs can be placed on the Town railing on each sign permit application.
- 3.3 Temporary Political Signs Allowed Political candidates will be limited to one (1) Temporary Political Sign on the Town railing.


## AMENDMENT TO THE TRAFFIC & PARKING COMMITTEE






